Actual Procedure: 1/26/2021: Drill 12.25 inch first intermediate hole to 5320 ft. 1/28/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5301 ft. Pump 20 bbls chem water, 20 bbls gel spacer, followed by 1193 sks of 13.5 ppg lead cmt, 416 sks of 14.8 ppg tail cmt. Drop plug and displace with 398 bbls of freshwater. 50 bbls of cement back. Pressure test casing to 2150 PSI for 30 minutes, good test. 1/29/2021: Drill 8.75 inch second intermediate hole to 11553 ft. 2/1/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11458 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 444 sks of 11.5 lead cmt, 147 sks of 13.2 ppg tail cmt. Drop plug and displace with 524 bbls of cut brine. 25 bbls of chem wash returned to surface. Est TOC at 4000 ft. Pressure test casing to 2620 for 30 minutes, good test.
