2/25/21 - MIRU and NU BOP. POOH with tubing. Pumped 15 bbls brine mud gel and pressured up to 1500 psi. Set a CIBP at 4320'. Displaced with 93 bbls brine mud gel. Spotted 25 sx Class "C" cement on top of CIBP to 4077' approximate TOC.
3/1/21 - Tagged plug at 4188'. Spotted a 30 sx Class "C" cement plug from 3627'-3319'. WOC. Tagged TOC at 3319'. Perforated at 2390'. Spotted a 30 sx Class "C" cement plug from 2440'-2162' approximate TOC.
3/2/21 - Tagged TOC at 2162'. Perforate at 2057'. Squeezed a 100 sx Class "C" in/out cement plug from 2110'-1650', this plug was ok'd by Gilbert Cordero with NMOCD-Artesia.
3/3/21 - Tagged TOC at 1262'. Perforated at 1153'. Squeezed a 33 sx Class "C" in/out cement plug from 1153'-892'. Tagged TOC at 830'. Perforated at 100'. Squeezed with 35 sx Class "C" cement from 100' up to surface.
3/4/21 - Dug up cellar and cut off wellhead. Installed dry hole marker as per NMOCD. Covered cellar and cut off anchors.
