**Actual Procedure:** 4/6/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5348 ft. 4/8/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 4952 ft. Pump 20 bbls chem wash, 20 bbls gel spacer, followed by 981 sks of 11.0 ppg lead cmt, 362 sks of 14.8 ppg tail cmt. Drop plug and displace with 372 bbls of freshwater. 50 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 4/9/2021: Drill 8.75 inch second intermediate hole to 11590 ft. 4/13/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11475 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 602 sks of 11.5 lead cmt, 114 sks of 13.2 ppg tail cmt. Drop plug and displace with 524 bbls of fresh water. 39 bbls of spacer returned to surface. Est TOC at 51 ft. Pressure test casing to 2525 for 30 minutes, good test.
