4/19/21 – MIRU and NU BOP.

4/20/21 – RIH with CIBP and tagged at 6223 ft. COA requires 7082 ft setting depth. Notified Bob Hoskinson and Jim Amos BLM-Carlsbad, they requested POOH and RIH open ended to set a balanced plug from the existing cement plug TOC 7359 ft to the planned CIBP setting depth of 7082 ft. Attempted to POOH, CIBP appears to have partially set during premature tag. During slow POOH to 5865 ft. CIBP fully set at 5865 ft, verified plug had set when tubing reached surface.

4/21/21-4/22/21 – RIH to mill and drill out CIBP at 5865 ft. After drilled out circulated water for 10 minutes to clear debris from well. Milled down to 7320 ft. Well is clear for new CIBP. Set new CIBP at 7082 ft.

4/23/21 – Loaded plugging mud. Pressure tested to 500 psi for 5min, held good. Spotted 25 sx Class C cement on top of CIBP to 6933 ft calc TOC, no tag. Spotted a 25 sx Class C cement plug from 4047 ft – 3898 ft calc TOC. WOC.

4/26/21 – Tagged TOC 3885 ft. Perforated at 2899 ft. Pressure tested to 500 psi for 5 min, held good. Perfs did not break down, no squeeze. Spotted a 40 sx Class C cement plug from 2949 ft – 2710 ft calc TOC. WOC.

4/27/21 – Tagged TOC 2720 ft. Required TOC 2750', approved to proceed. Spotted a 25 sx Class C cement plug from 1704 ft – 1555 ft calc TOC, no tag. Spotted a 25 sx Class C cement plug from 1295 ft – 1146 ft, no tag. Spotted a 25 sx Class C cement plug from 930 ft – 781 ft, no tag. Spotted a 25 sx Class C cement plug from 427 ft – 278 ft calc TOC. WOC. Tagged TOC 263 ft. Required TOC 278 ft, approved to proceed. Perforated at 50 ft. Perfs broke down, will squeeze. Squeeze 40 sx Class C cement from 50 ft up to surface in casing and annulus.

5/1/21 - Cut off wellhead. Installed dry hole marker as per BLM. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
