Standard bottom hole pressure – 120-180 psig (interpolated from surface)
 Current bottom hole pressure – 1360+ psig (interpolated from surface)
 Bottom hole fluid being recovered – none at this time. Both wells listed above are currently shut-in due to off-set Operator stimulation, expecting to flow back reservoir fluid with additional N2.
 Nitrogen content in natural gas – Not available at this time, currently waiting for LOGOS to finish pumping operations.

DJR plans to return these two wells to production on May 30, 2021. Gas samples will be collected twice per week per NMAC 19.15.27.8 and will be available to the division upon request. DJR will route the natural gas into the gathering pipeline as soon as pipeline specifications are met.

DJR Operating, LLC will remit payment for the associated royalties and taxes for each well's flared gas. Taxes and royalties will be calculated as follows: 1) Gas volumes for each well will be measured and recorded using the existing sales meter on the pad; 2) Royalties and taxes will be based on current wellhead pricing; 3) Royalty and tax basis will be calculated on well-by-well basis and will remain consistent with accounting methods prior to the flaring event; 4) Royalties and taxes will be paid on shrunk gas volumes and NGL yields using the average factors from previous Enterprise statement.

Estimated value of oil and gas is calculated as follows: 1) Gross wellhead price of \$2.80/mcf, prior to transportation costs; 2) Gross wellhead price of \$63/bbl, prior to transportation costs.

Submitted to the Bureau of Land Management: BLM Form 3160-5 submitted electronically through AFMSS2 System for the two wells listed above that involve Federal or Allottee minerals. Once the BLM has approved the sundry forms, they will be forwarded to the NMOCD for their approval. Each sundry form includes the following attachments:
