4/26/21 - MIRU and NU BOP. RIH and tagged up high at 3054'. Received verbal permission from Carrie with NMOCD-Hobbs to cement at 3054'. Spotted a 25 sx Class "C" cement plug from 3054'-2712', tagged. Dropped 1.25" ceramic ball. Pumped 8 bbls and pressured up to 1500 psi. Set a CIBP at 2327'. Displaced with 75 bbls brine gel mud. Tested 5-1/2" casing to 500 psi, failed. Spotted 25 sx Class "C" cement on top of CIBP to 2126, tagged.
4/27/21 - Hole in 5-1/2" casing isolated between 1180' and 1231'. Spotted a 25 sx Class "C" cement from 2098'-1857' calc TOC. Gravity squeeze hole in 5-1/2" casing with 25 sx Class "C" cement at 1250', approved by Carrie NMOCD-Hobbs.
4/28/21 - Tagged TOC 994', false tag. Perforated at 974'. Tagged TOC 1118'. Gravity squeeze with 25 sx Class "C" cement at 994', permission given by Carrie NMOCD-Hobbs. Tagged TOC 802'. Perforated at 410'. Attempted to establish rate thru perf. Gravity squeeze with 30 sx Class "C" cement at 462', permission given by Carrie NMOCD-Hobbs.
4/29/21 - Tagged TOC 210'. Perforated at 100'. Established rate thru perf. Squeezed with 40 sx Class "C" cement from 100' up to surface.
5/6/21 - Cut off wellhead. Installed dry hole marker. Cover cellar and cut off anchors. WELL IS PLUGGED AND ABANDONED.
