Drill 9.875 inch first intermediate hole to 8862 ft, switch to 8.75 inch hole and drill to 11840 ft. 6/16/2021: Run 7.625 inch 29.7 lb P-110 intermediate casing to 11818 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 1097 sks of 10.5 ppg lead cmt, 137 sks of 13.2 ppg tail cmt. Drop plug and displace with 540 bbls of freshwater. Full returns to surface.
