 5/10/21 – Displaced with 263 bbls brine gel mud. Tested casing to 500 psi, good. Spotted 25 sx Class "H" cement on top of CIBP to 7480', tagged. Spotted a 25 sx Class "C" cement plug from 5731'-5577' calc TOC. Spotted a 25 sx Class "C" cement from 5082'-4928' calc TOC.
 5/11/21 – Spotted a 25 sx Class "C" cement plug from 2520'-2366' calc TOC. Spotted a 25 sx Class "C" cement plug from 2267'-2113' calc TOC. Perforated at 1155'. Attempted to establish rate through perf.. Tested to 500 psi, good. Spotted a 30 sx Class "C" cement plug from 1205'-1016', tagged. Perforated at 100'. Attempted to establish rate through perf. Tested to 500 psi, good. Spotted a 25 sx Class "C" cement plug from 152' up to surface.
