Run 13.375 inch 54.5 lb J55 surface casing to 1237 ft. Pump 20 bbls freshwater, 40 bbls gel with CTB-15, followed by 1010 sks of cement. Pressure test casing to 1500 PSI for 30 minutes, good test 6/12/2021: Drill 9.875 inch first intermediate hole to 8444 ft. Switch to 8.75 inch hole and drill to 12027 ft. 6/17/2021: Run 7.625 inch 29.7 lb P-110 intermediate casing to 11921 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 1085 sks of cement. Pressure test casing to 1500 PSI for 30 minutes, good. <b>6/10/2021</b> Spudded well.
