Pump 40 bbls gel water spacer, followed by 640 sks of 13.5 ppg lead cmt, 345 sks of 14.8 ppg tail cmt. Drop plug and displace with 144 bbls of pink mud. 125 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
