Overflow Energy SPUD the Rose SWD #1 on 9/22/2019 at 14:30 and drilled to a depth of 414'. On the 9/23/2019, 10 joints of 20" 94# J-55 BTC surface casing was run to bottom and cemented as follows:

- 20bbl fresh water spacer
- 1,295 sxs of 14.8ppg Class C, Yield = 1.34sxs/ft<sup>3</sup>
- Returned 35bbl of cement to surface.

On 09/25/2019, pressure tested the annular BOP and surface casing to 700 psig for 30 minutes and tested good.
