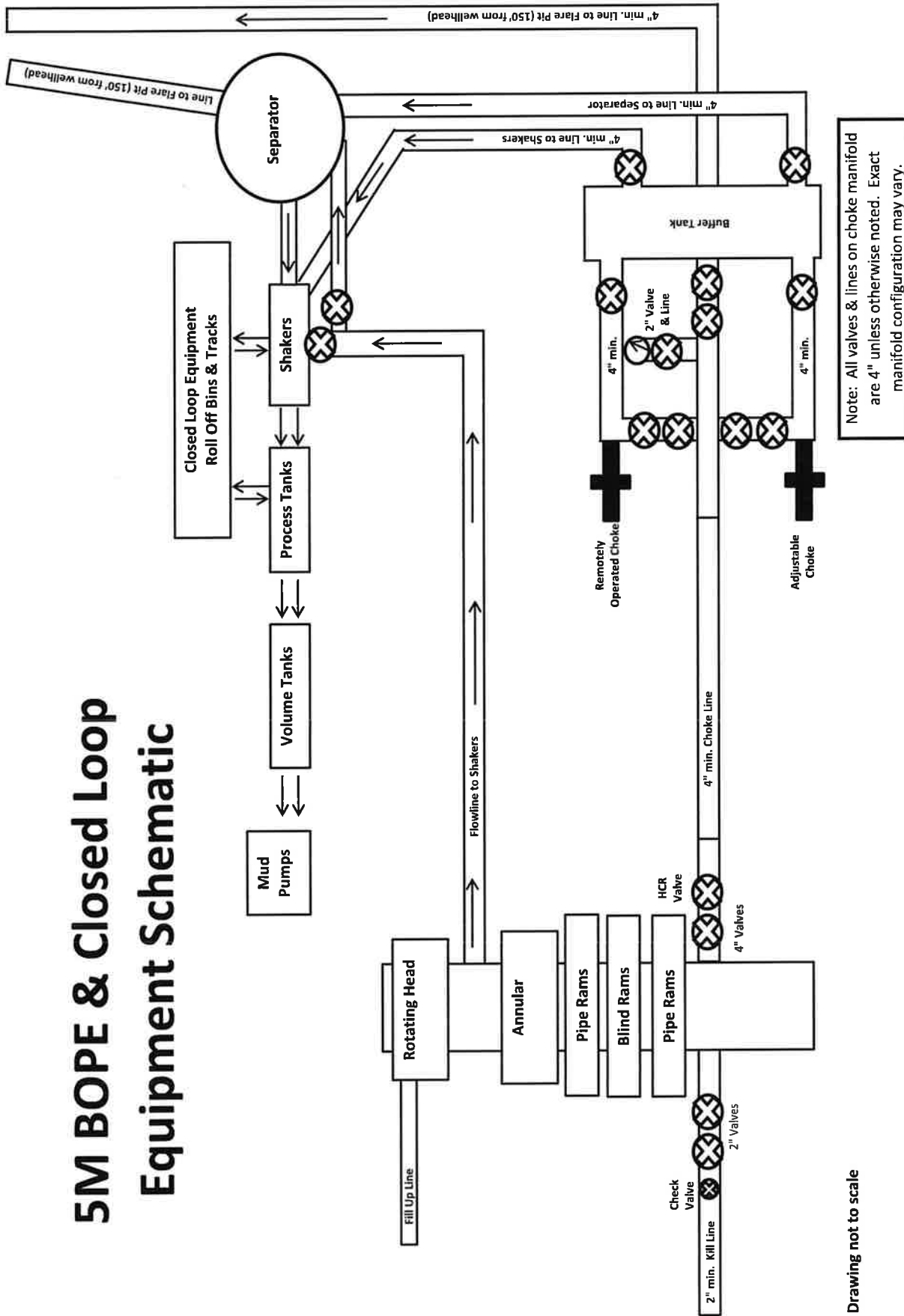

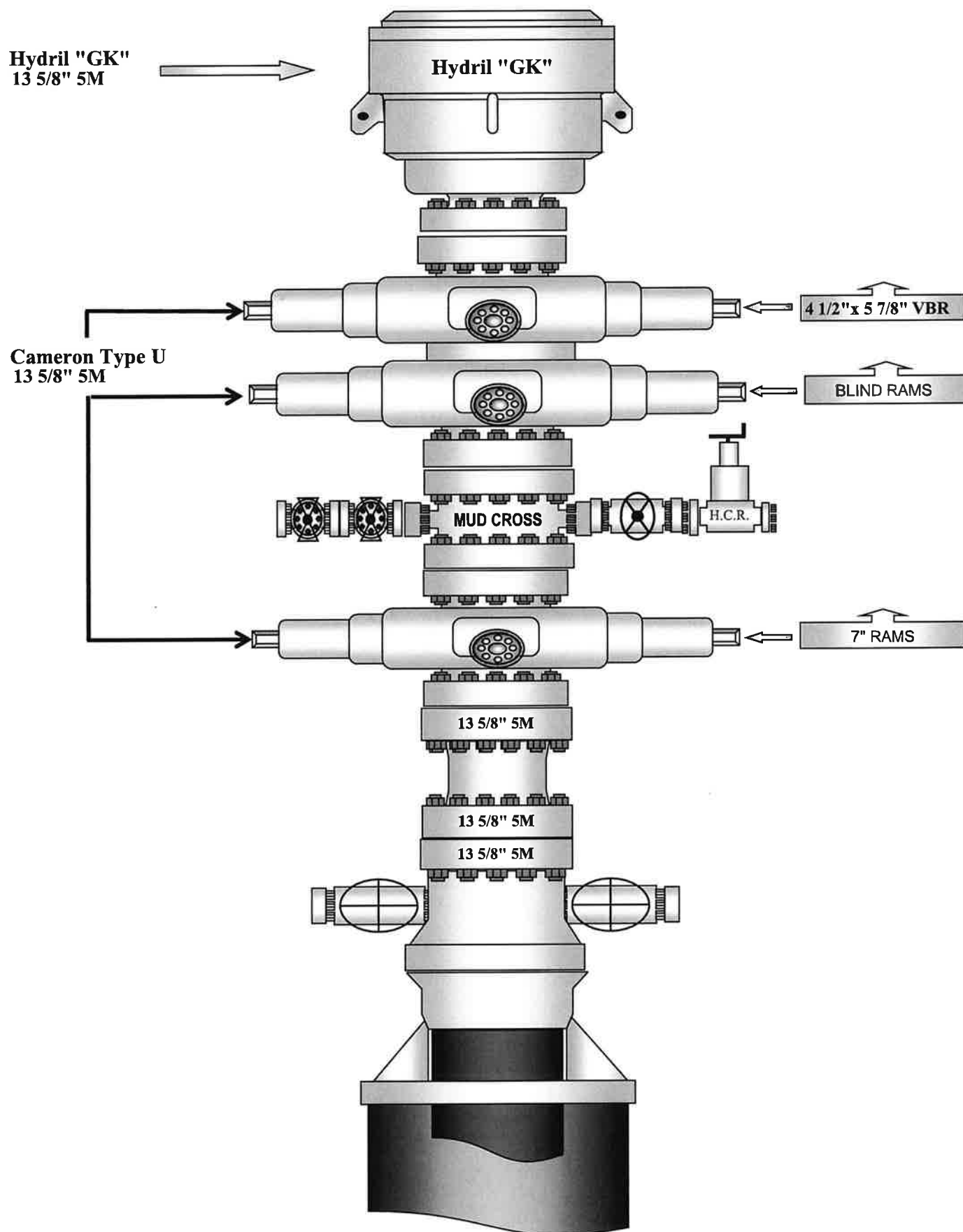

5M BOPE & Closed Loop Equipment Schematic



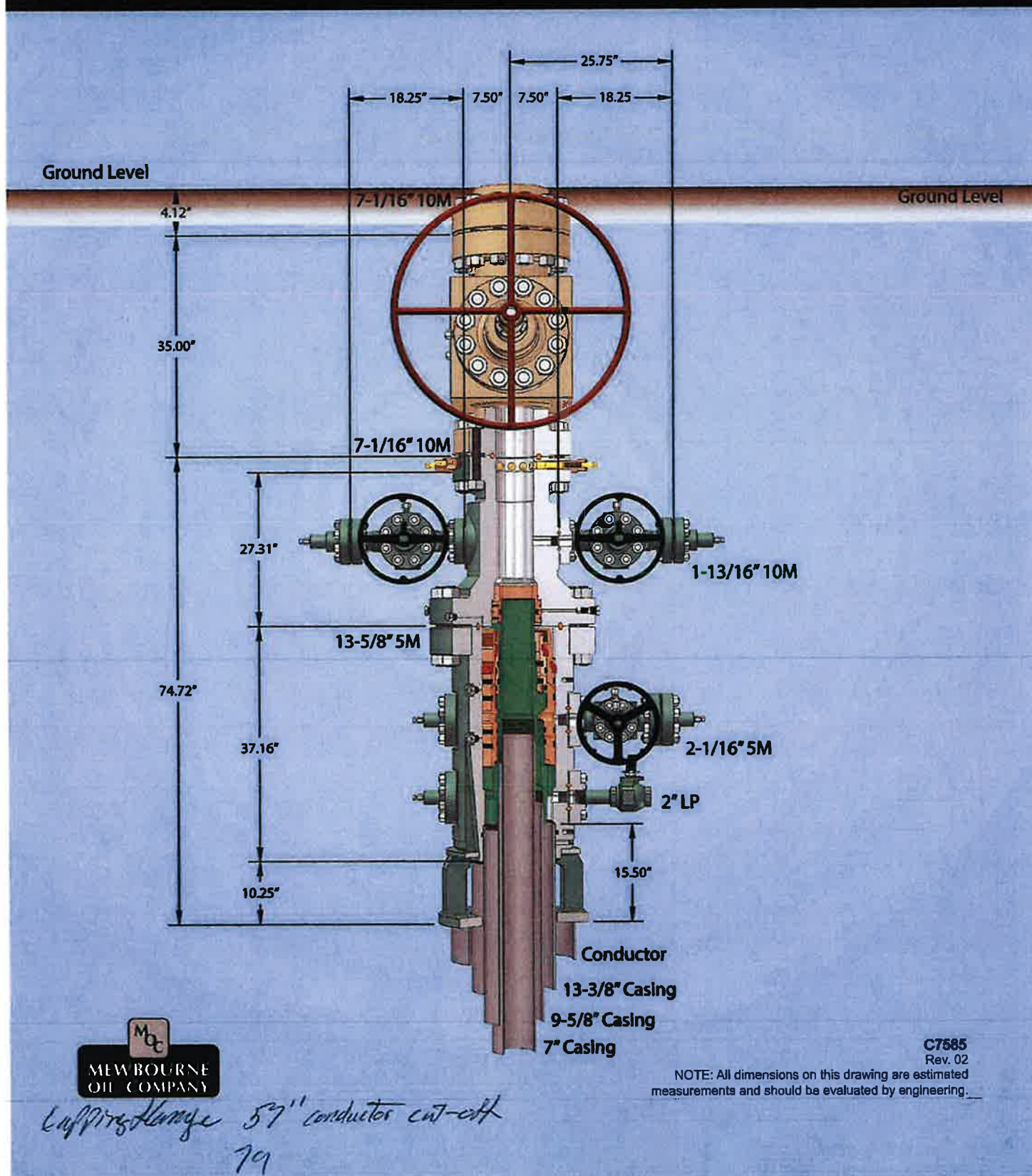
