8/5/21: Spud well.

8/6/21: TD 17-1/2" hole @ 1870'. Ran 50 joints of surface csg. to 1860'. 13-3/8", 54.4#, J-55. Cement lead cmt., 1020 sxs, 1.80 yield, Prolite; Tail w/420 sxs, 1.34 yield, CLH to surface. 125 bbls returned to surface. Tested surface csg. to 1100# for 30 minutes. Good test.

8/8/21: TD 12-1/4" hole @ 5319'. Ran 131 joints 9-5/8" intermediate csg., 40#, J-55 to 5517'. Cement lead 820 sks., 3.43 yield; Tail w/200 sxs., 1.34 yield, Prolite. Circulate cement to surface, 64 bbls. returned to surface. Tested intermediate csg. to 1500# for 30 minutes. Good test. Drill 8-3/4" vertical section to 9977'
