Pumped 188 bbls of lead cement (430 sks) @ 11.1 ppg (3.31 cuft/sk, 50:50:12 Poz:H:Gel w/ 5% Salt + 0.6% Retarder + 0.4 Defoamer + 0.5% Suspension Aid + 0.5% Anti Settling). Pumped 221 bbls of tail cement (1050 sks) @ 15.6 ppg (1.18 cuft/sk, ClassH w/ 0.5% Fluid Loss + 0.1% Dispersant + 0.2% Retarder) followed by 5 bbls of sugar water. Shut down, washed pump, dropped latch-in top plug w/ 4k disk and began displacement. Pumped 20 bbls of sugar water followed by 450 bbls of fresh. Bumped plug on time with a final displacement of 470 bbls at 4,500 psi. Pressured up 275 psi over to 4,775 psi, and bled back 5 bbls. Circulated ~ 50 bbl (84sks) of cement to surface.
