6/18/21 – Spotted a 35 sx Class "C" cement plug from 7407'-7064' calc TOC. Spotted a 30 sx Class "C" cement plug from 6526'-6230' calc TOC. Spotted a 30 sx Class "C" cement plug from 5360'-5064' calc TOC. Spotted a 30 sx Class "C" cement plug from 4164'-3868' calc TOC. Spotted a 30 sx Class "C" cement from 2301'-2005' calc TOC.

6/22/21 – Tagged TOC 1955'. Perforated at 1312'. Attempted to establish rate through perf. Tested to 500 psi, good. Spotted a 35 sx Class "C" cement plug from 1387'-1020', tagged. Perforated at 408'.
