10/29/2020 Installed 4 ½" X 8 5/8" Larkin wellhead on the 4 ½" casing. Installed BOP. Picked up 4 ½" Scraper with a bit and RIH with workstring. Stacked out at 3247'. Washed down to 3257' and stopped making progress. Called BLM. Circulated MLF and spot 25 sx cement at 3257'. POOH and SION.

10/30/2020 Tagged cement at 3568'. Caught circulation and tested casing to 500#. Casing good. Called BLM. POOH with tubing and perforated casing at 1998'. Set packer at 1586' and established rate into perfs. Squeezed perfs with 50 sx cement with CaCl. No communication with the surface head while pumping. ISIP 700#. Left packer set. WOC and tagged cement at 1771'. POOH with tubing and perforated casing at 1488'. Set packer at 1015'. Established injection rate and squeezed perfs with 50 sx cement. No communication with the surface head. Left packer set and shut in. Shut down.

11/2/2020 Tagged cement at 1269'. Perforated 4 ½" casing at 462'. Established circulation. Laid down remaining pipe. Pumped cement down the 4 ½" casing to the perfs at 462' and up the annulus to surface. Took 120 sx to get good cement to the steel pit. Rigged down. Dug out wellhead and cut off. Filled up both strings of casing with 10 sx cement. Cement remained at surface. Installed marker and removed the anchors.
