**Actual Procedure:** 8/12/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 3626 ft. 8/14/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 3611 ft. Pump 20 bbls chem water, 20 bbls fresh water, followed by 793 sks of 12.8 ppg lead cmt, 401 sks of 14.8 ppg tail cmt. Drop plug and displace with 270 bbls of freshwater. 20 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/15/2021: Drill 8.75 inch second intermediate hole to 10533 ft. 8/18/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 10440 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 739 sks of 11.5 lead cmt, 163 sks of 13.2 ppg tail cmt. Drop plug and displace with 478 bbls of water. 120 bbls of cement to surface. Pressure test casing to 2350 for 30 minutes, good test. First Intermediate Casing Details: Casing ran: 8/14/2021, Fluid Type Brine, Hole 12.25 inch, Csg Size 9.625 inch, Weight 40 lbs, Grade J55, Est TOC 0 ft, Depth set 3611 ft, Cement 1194 sacks, Yield 1.33, Class C, Pressure Held 1500 psi, Pres Drop 0.
