3. PU pump truck, circulate well with treated water, pressure test casing to 500psi for 30 minutes.
4. Remove RBP.

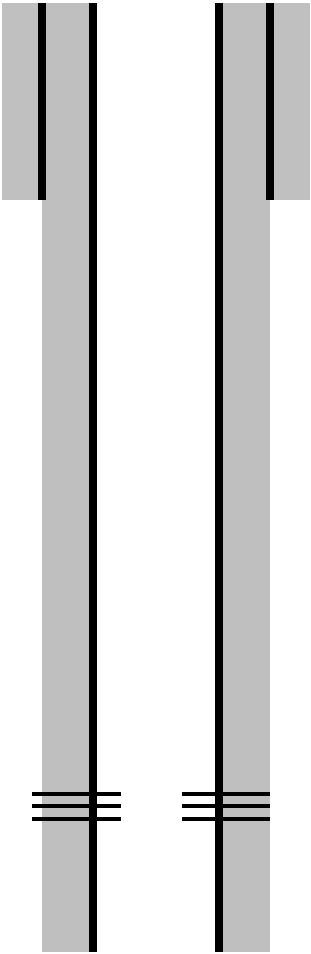
