



- 4. RU casing crew and RIH with 4.5" liner and land casing at 6,730'.
- 5. RU cementers and pump primary liner cement job. RD cementers and WOC.
- 6. RIH w/bit and drill out cement to casing shoe, POOH WS.
- 7. RU WL and perforate 4.5" liner from 6,440'-6,627'.
- RIH w/WS and treatment packer and acidize perforations w/10,000 gals HCL and ball sealers.
