**Actual Procedure:** 8/24/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 3691 ft. 8/25/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 3672 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 784 sks of 12.8 ppg lead cmt, 427 sks of 14.8 ppg tail cmt. Drop plug and displace with 275 bbls of freshwater. 85 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/26/2021: Drill 8.75 inch second intermediate hole to 11390 ft. 8/30/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11303 ft. Pump 10 bbls chem wash, 10 bbls visc water, followed by 552 sks of 10.5 lead cmt, 183 sks of 13.2 ppg tail cmt. Drop plug and displace with 513 bbls of water. 150 bbls of cement to surface. Pressure test casing to 2500 for 30 minutes, good test. First Intermediate Casing Details: Casing ran: 8/25/2021, Fluid Type Brine, Hole 12.25 inch, Csg Size 9.625 inch, Weight 40 lbs, Grade J55, Est TOC 0 ft, Depth set 3672 ft, Cement 1211 sacks, Yield 1.33, Class C, Pressure Held 1500 psi, Pres Drop 0.
