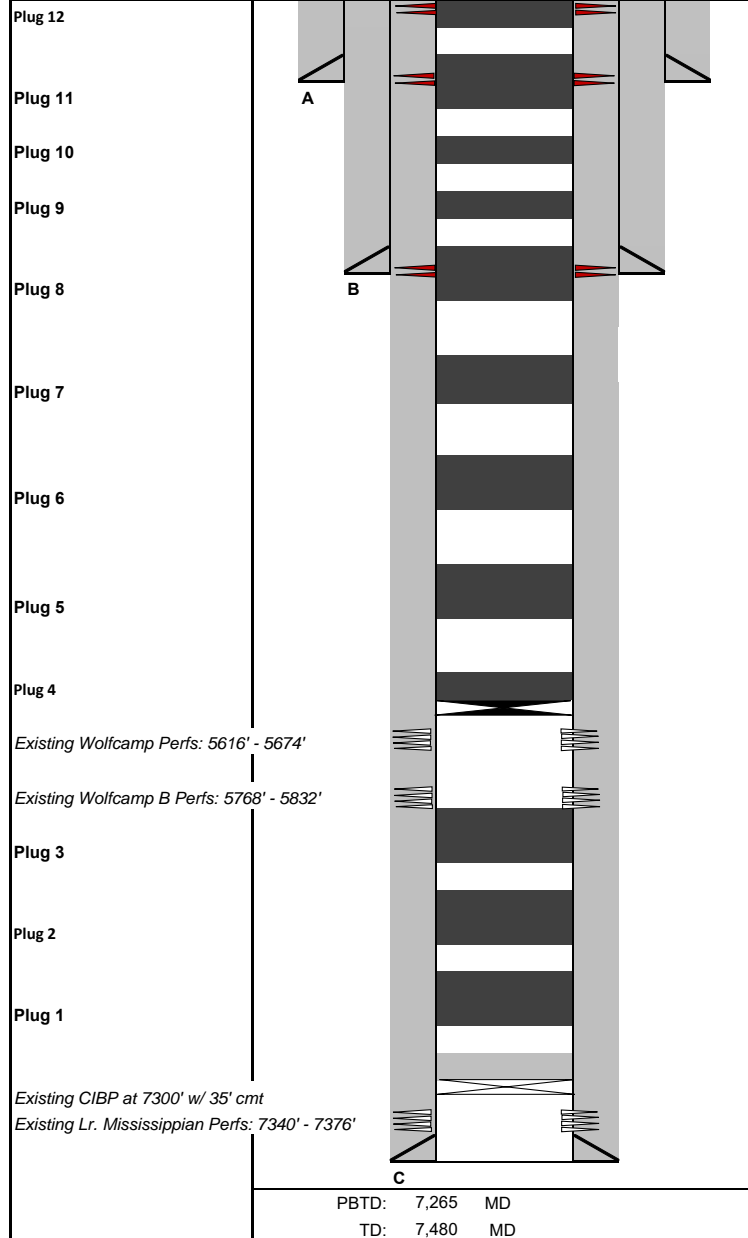

8/25/21 – Set a CIBP at 5566', tagged. Spotted 30 sx Class C cement on top to 5381' calc TOC. Tagged TOC 5395'. Witnessed by Kevin Bussell with BLM-Roswell. Spotted a 25 sx Class C cement plug from 4737'-4585' calc TOC.
8/26/21 – Spotted a 25 sx Class C cement plug from 3948'-3749' calc TOC. Spotted a 35 sx Class C cement plug from 2467'-2240' calc TOC. Perforated at 1556'. Attempted to establish injection rate.
