8/17/21 - MIRU and NU BOP. Tried to release packer and could not. Spoke with Kent Caffall with BLM-Carlsbad who spoke to Jim Amos with BLM and a variance was approved. Variance is to J off of packer and set a CIBP just above packer and cap with cement.

8/19/21 - Set a CIBP at 9220' and tagged. Circulated wellbore with 220 bbls fresh water. Pressure tested to 550 psi, good. Spotted 25 sx Class H cement on top of CIBP to 8990', tagged.

8/23/21 - Mixed and displaced 25 sx Class H cement from 8313'-8085' calc TOC. Mixed and displaced 25 sx Class C cement from 7330'-7076' calc TOC, Mixed and displace 25 sx Class C cement from 4076'-3822' calc TOC. Perforated at 3746'.
