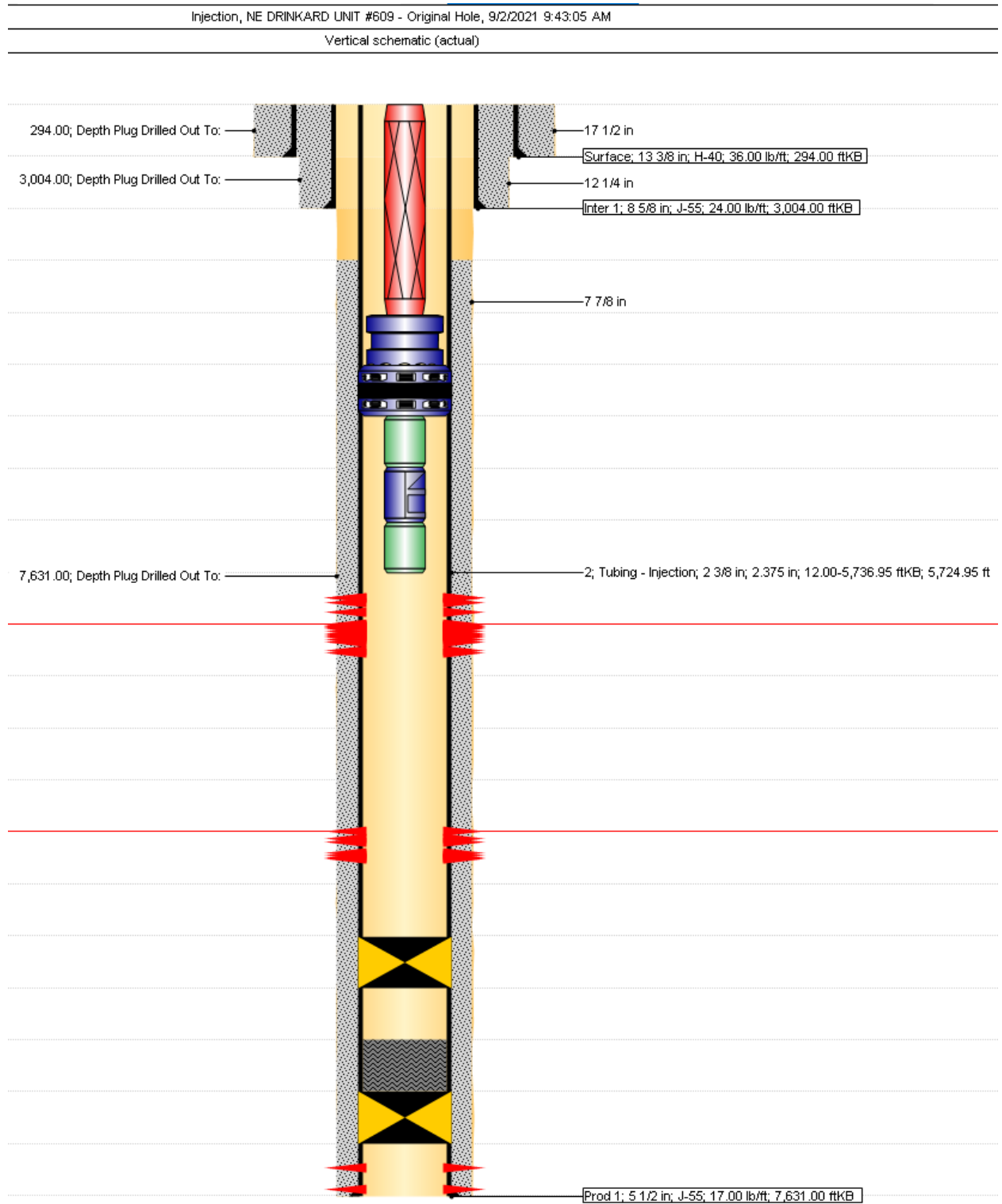

Procedure

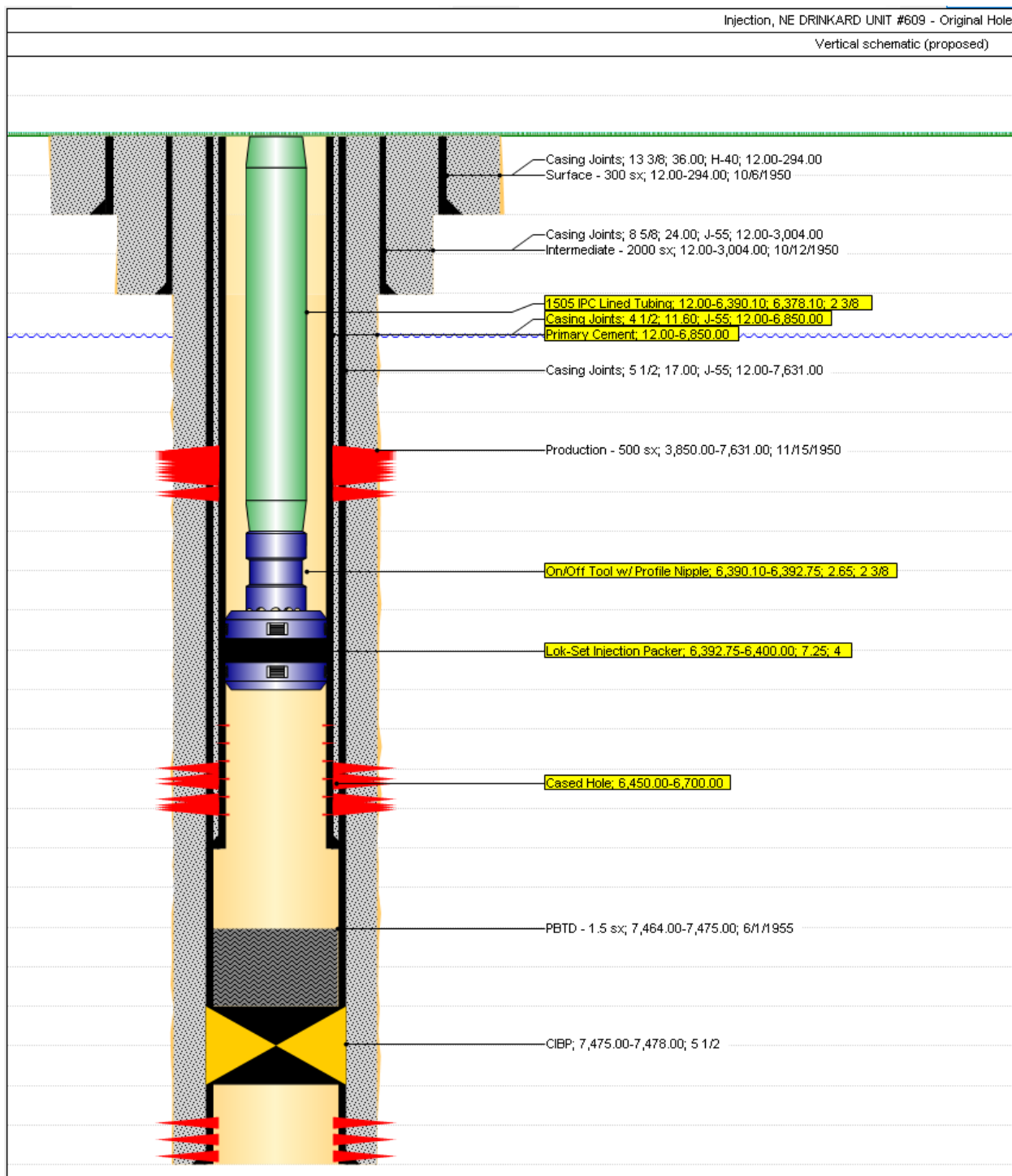
1. RU WSU, ND WH and NU BOP.
2. POOH with existing injection string and LD TBG and PKR.
3. RU air-foam unit and MU bit and RIH to cleanout to PBTD (7,464'), POOH.
4. MU bit and scraper and clean casing out to PBTD, stand back workstring and prep for casing run.
5. RU casing crew and RIH with 4.5" flush joint liner and land casing at 6,850'.
6. RU cementers and pump primary liner cement job. RD cementers and WOC.
7. RIH w/bit and drill out cement to casing shoe, POOH WS.
8. RU WL and perforate 4.5" liner from 6,450'-6,700'.
9. RIH w/WS and treatment packer and acidize perforations w/10,000 gals HCL and ball sealers.

POOH LD WS.
10. RIH w/new 1505 IPC 2-3/8" J-55 TBG and injection packer and set at 6,400'.
11. RDMO WSU and turn well to injection.
