ConocoPhillips Company respectfully submits the proposal below to address a failed MIT test. The well was shut in as requested by NMOCD 4/21/21.

Proposed Operation:

- MIRU WSU
- POOH w/ 2-3/8" tbg and 4" packer
- MIRU wireline
- Wireline set 2-3/8" bridge plug at 3,750' inside 2-3/8" liner
- RDMO wireline
- Pressure test bridge plug to 500 psi
- If pressure holds, notify NMOCD to witness MIT. Run MIT to 500 psi, hold for 30 minutes
- If pressure does not hold, hydrotest in 2-3/8" tubing with 4" packer. Do not run packer below liner hanger set at 3,375'. Hunt for leak.
- Submit casing repair/remedial cement proposal to BLM and NMOCD after location of leak has been determined.
- RDMO WSU.
- Successful MIT chart will be submitted to BLM and NMOCD with subsequent report.

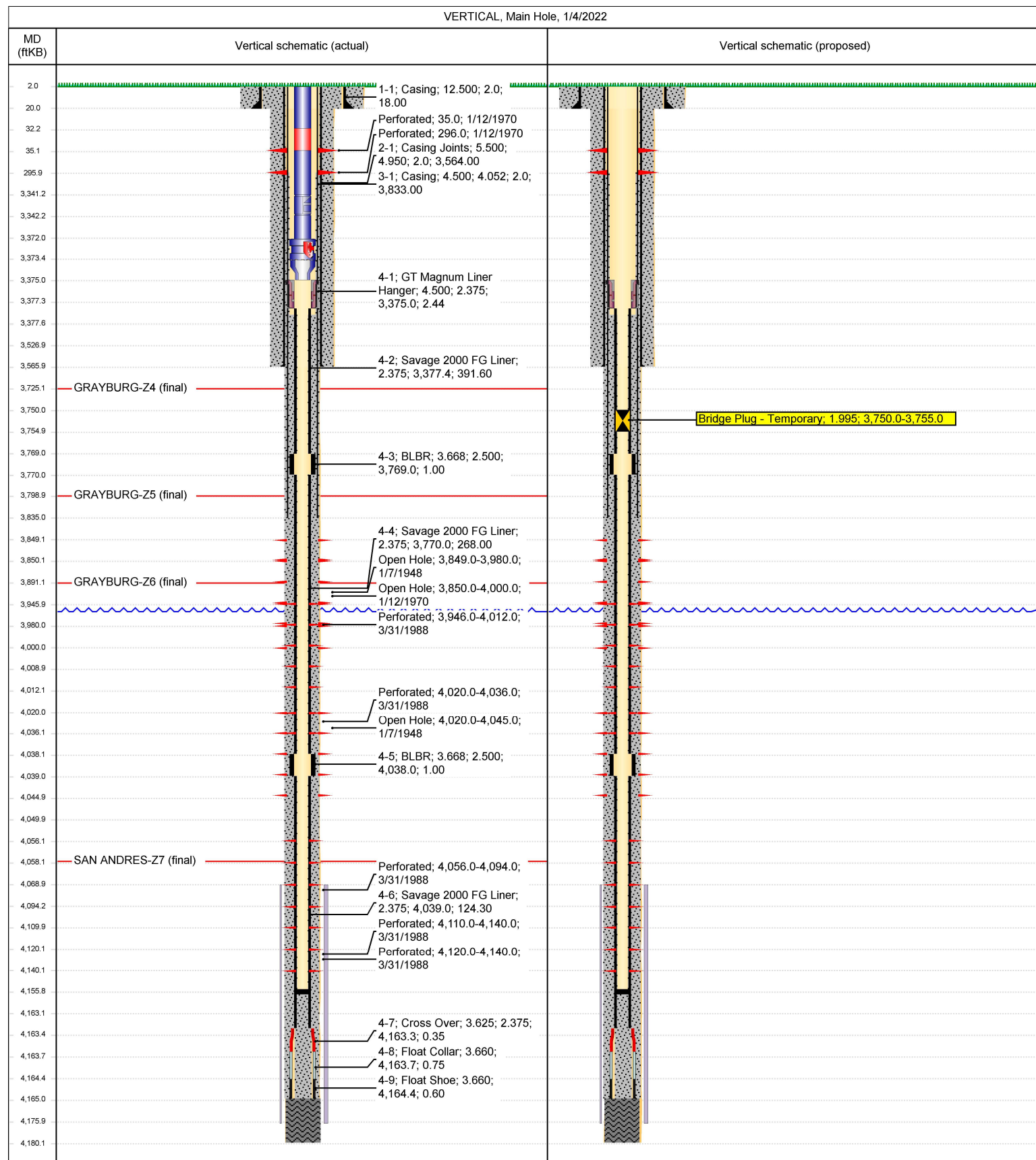
