Float collar @ 127'. Centralizers on joints 2 & 3. Cemented w/160 sks Class G cement (188 cu ft) w/1% CaCl₂, 0.25#/sk celloflake, 0.2% CD-2 (15.8#/gal, 1.18 cu ft/sk, 5 gps mix). Dropped plug. Displaced w/8 bbls water. Circulated 10 bbls cement to surface. Bumped plug. Plug on bottom @ 9:00 AM 10/20/2021. WOC 10 hrs. RU Wilson Services for testing @ 10:00 PM 10/20/2021.
