11/30/21 – Set a CIBP at 1866', tagged. Spotted 50 sx Class "C" cement on top of CIBP to 1129', tagged. Gilbert Cordero with NMOCD-Artesia ok'd to combine plugs 1 & 2. Perforated at 320'. Contacted Gilbert Cordero with NMOCD-Artesia, casing has holes surface to perfs. Ok'd to spot for gravity squeeze. Spotted a 50 sx Class "C" cement plug from 370' and circulated up to surface. Topped off wellbore with cement to surface. Visual cement to surface.

12/21/21 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
