1. Hold pre-job safety meeting. Comply with all **NMOCD**, **BLM**, and HEC safety and environmental regulations. Notify NMOCD and BLM 24 hours prior to MIT and get witnesses on location for test if necessary. Record pressures across all strings.

2. RU pump truck. Load casing, as necessary. Perform MIT against bridge plug at 1768' to 580 psi for 30 minutes on a 2 hour chart with a 1000 lb spring. SI well. RD pump truck. Send MIT into regulatory.

Well Name: Maddox WN Federal 12 - CURRENT WELLBORE SCHEMATIC

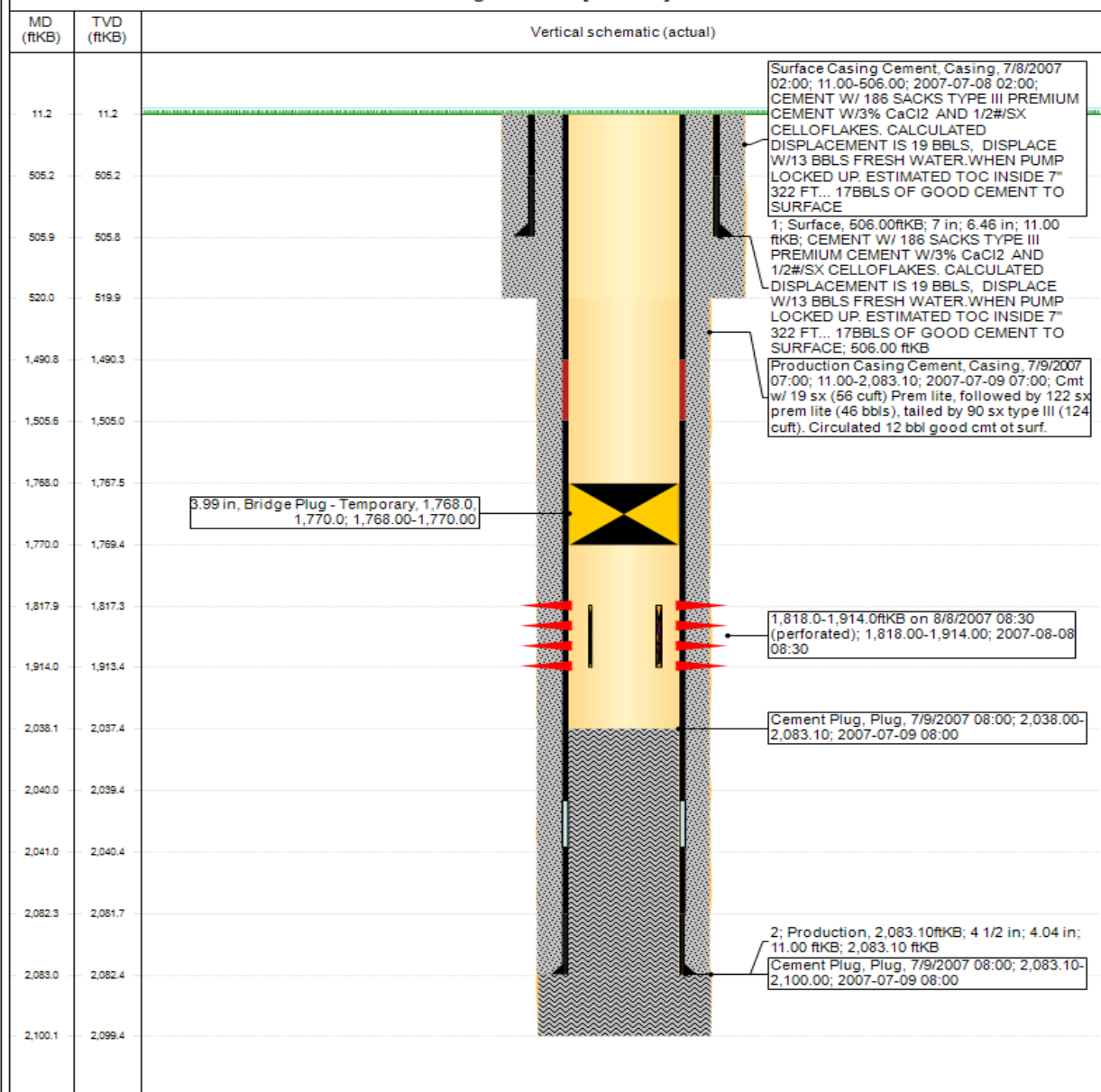
