1/12/2022 Moved in rig. Set large matting board and spot rig.

1/13/2022 Rig up and install BOP. Released TAC and tally OOH with 2 3/8" tubing. 127 joints of tubing. TAC 6 joints off S/N. Picked up 4' perforated sub with a bull plug and RIH with 127 joints of tubing.

1/14/2022 Moved in workstring. Tagged existing CIBP at 7998'. Spot 10 sx Class H cement on top of CIBP at 7998'. POOH and SION.

1/17/2022 Tagged cement at 7909'. Pumped mud. POOH to 6067' and spot 30 sx Class C cement with CaCl. WOC and tagged cement at 5773'. POOH to 4735' and spot 25 sx cement. POOH and SION.

1/18/2022 Tagged cement at 4481'. POOH to 4290' and spot 30 sx Class C cement with CaCl. WOC and tagged cement at 4211'. Spot 30 sx cement at 4211' with CaCl. POOH and SION.

1/19/2022 Tagged cement at 4211'. Set 5 1/2" CIBP at 3956' as per conversation with the BLM. Tagged CIBP with tubing. Caught circulation with MLF and pressure tested the casing. Good to 500#. Spot 25 sx Class C cement on top of the CIBP. POOH and SION.

1/20/2022 Tagged cement at 3828'. Tubing was plugged. Tripped tubing and RIH to 2452'. Spot 55 sx Class C cement. POOH and SION.

1/21/2022 Tagged cement at 1901'. POOH to 838' and circulated cement to surface with 55 sx. Rigged down and dug out the cellar. Removed the wellhead. Mixed 10 sx cement and filled up all three casing strings to surface. Installed above ground marker, removed the anchors and cleaned the steel pit.
