DESCRIPTION OF WORK:

9/10/21: Notified BLM 9/9/21. Well was spud @14:15.

9/11/21: Contacted Gabriel Beneway on notification for 13-3/8" setting of casing and cementing same. TD 17-1/2" surface hole to @ 1905'. Rig up casing crew. Ran 13-3/8", 54.4#, J-55 surface csg. to 1891'. Shoe @ 1891' and float collar @ 1844'. Cement lead, 825 sks., 1.9 yield, CLC; Tail w/260 sks., 1.35 yield, CLC. Full returns throughout job. Circulate to surface. 295.5 sx returned to surface. Test casing to 1500# for 30 minutes. Good test.

9/17/21: Notified BLM, Long Vo, Pet., requesting to change the permitted Intermediate casing setting depth from 5830' to 5600'+. Received verbal permission from Mr. Vo. Sent in Sundry of request, ID #2634821 for written approval.

9/17/21: Test BOP. Testing breaks with Lone Star Hydrostatic 250 psi low/5,000 psi high 10 minutes each test.

9/18/21 thru 9/19/21: Drill 12-1/4" intermediate casing hole to 5153'. Notified Catherine Jess w/BLM @ 1500 CST of intent to run 9-5/8" intermediate casing and cement. TD 12-1/4" hole @ 5620'. Ran 9-5/8 40#, HCL- 80 and J-55 LTC intermediate csg., to 5605'. Shoe @ 5605', Float collar @ 5559', DV toll @ 2182' and packer @ 2193'. Released rig to #502H

9-20-21: 1st Stage lead, 1515 sks., 1.84 yield, Poz/65 CLC; Tail w/360 sks., 1.27 yield, Poz 50 CLC. Open DV tool @ 2182', 2nd Stage Lead 1015 sxs, 1.83 yield, Poz 65 CLC, Tail 100 sxs, 1.33 yield, CLC. Close DV tool w/2000 psi. Circulate to

surface. 600 sxs returned to surface. Test casing to 1500# for 30 minutes. Good test.

10/14/21: Drill 8.75" vertical hole from 5,630 to 9,180'.

10/15/21 thru 10/17/21: Drill vertical from 9,180' to KOP 9,345. Drill curve from 9,345' to 10,265'. Drill 8.75" curve section to 9,975' to 10,265'. Drill 8.75" lateral from 10,265 to 14,585'.

10/18/21 through 10/20/21: Drill lateral 8.75" from 14,585' to 16,622'.

10/20/21 through 10/21/21: TD 8-1/2' lateral and TD well @ 17,968'. Notify Katherine Jeff w/BLM of intent to run 5-1/2" production casing.

10/22/21: Notify Katherine Jeff w/BLM of intent to pump production cement @ 13:06. Run 5-1/2" production csg., 20#, P1110 EC to 17,850'. Lead cement 840 sks, CLC, 3.39 yield; tail w/2175 sks, CLH, 1.21 yield. Cement to surface. 244 sks. returned to surface. Back out & lay down landing joint; set pack off & pull test 50,000; test lower pack off seals to 5,000 psi/10 minutes, good test. RR to Golden Tee 31 Federal #302H.
