Mike Gilbreath onsite to witness. 11/18/21 to 11/20/21: Drill 8.75 inch hole from 384 ftKB to 5539 ftKB. KOP 4830' MD. 11/21/21: Run 121 jts of 7 inch 26# J55 LTC casing set from surface to 5529' MD. Float collar at 5479' MD. Cement: 5000 psi test on lines. Test good. Cement with Class G cement, 55% excess on both lead & tail. Lead: 176 bbls (440 sx) 12.3 ppg, 2.25 yield, 12.71 gps. Tail: 51 bbls (194 sx) 13.5 ppg, 1.47 yield, 7.01 gps (634 sx total). Bump plug 1460 psi, pressure up to 2015 psi & hold for 5 min. 50 bbls good cement back to surface. TOC: surface BOC: 5529'.
