Hydraulically fractured the Fruitland Coal formation on 2/13/2022 through Fruitland Coal perforations at 464'-478' (14') & 496'-506' (10'), 24' total, 4 spf, 96 holes total. Fractured well w/70,000 gallons 70Q N2 foam and 100,000 lbs 20-40 sand w/average pressure of 660 psi. Well flowed back through flowback system and flare on 2/13/22 after the frac job for 2 hrs. Well died down to 0 psi. Moved workover rig to location on 2/17/22. Ran 2-7/8", 6.4# tubing to 542'. Move workover rig off location on 2/17/22. Frac fluid disclosure uploaded to FracFocus.
