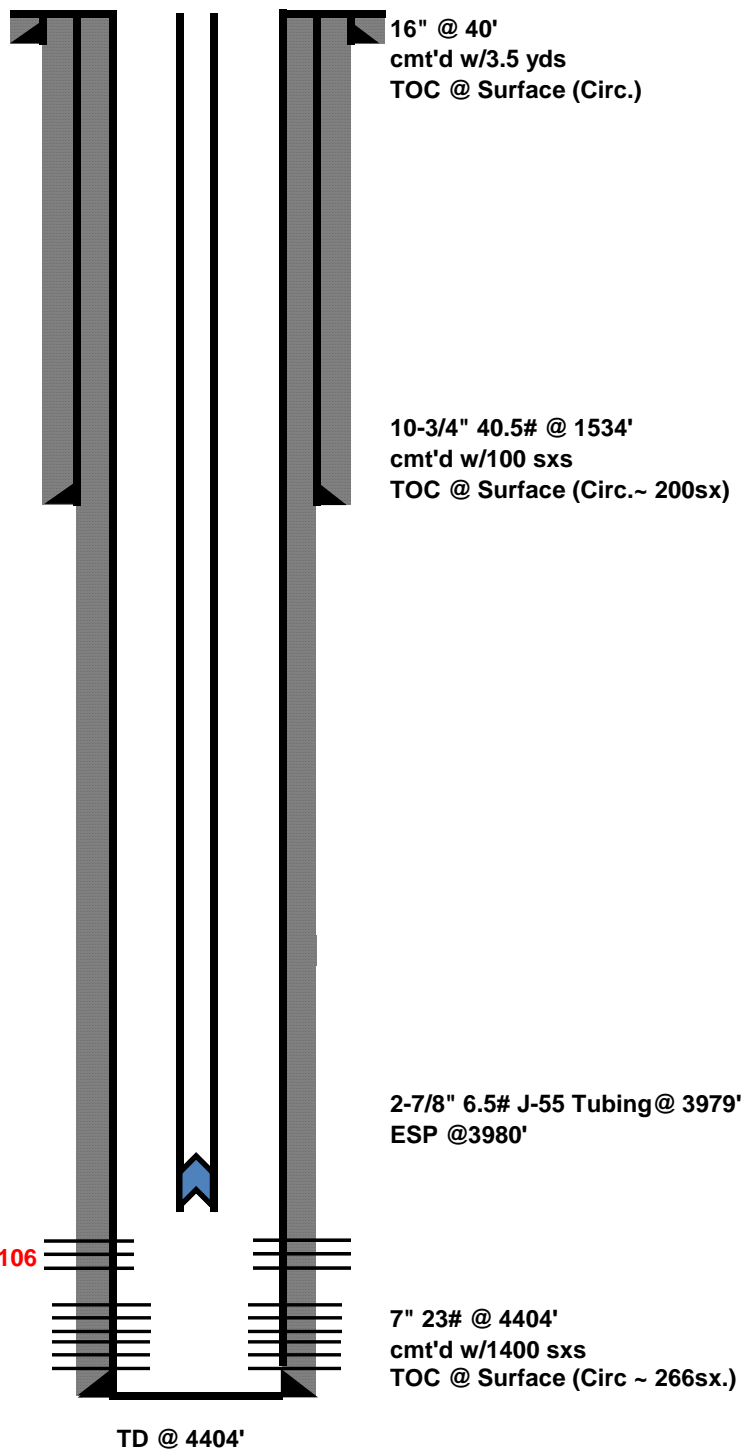

- POOH with bit and RIH with CICR on cementing string, set CICR 4000'
- RU Cement trucks and cement Sqz Existing perfs. RD Cement truck, POOH w/ cementing string, RIH bit and WOC
- DO CICR, continue DO Cement to PBTD, Circulate clean
- POOH with bit, PU and RIH with 5-1/2" partial liner, RU Cement trucks and cement liner, RD Cement trucks and POOH with stinger, RIH with 6-1/8" bit.
- DO to top of liner, POOH with bit, RIH with 4-3/4" bit and CO to PBTD, POOH with bit

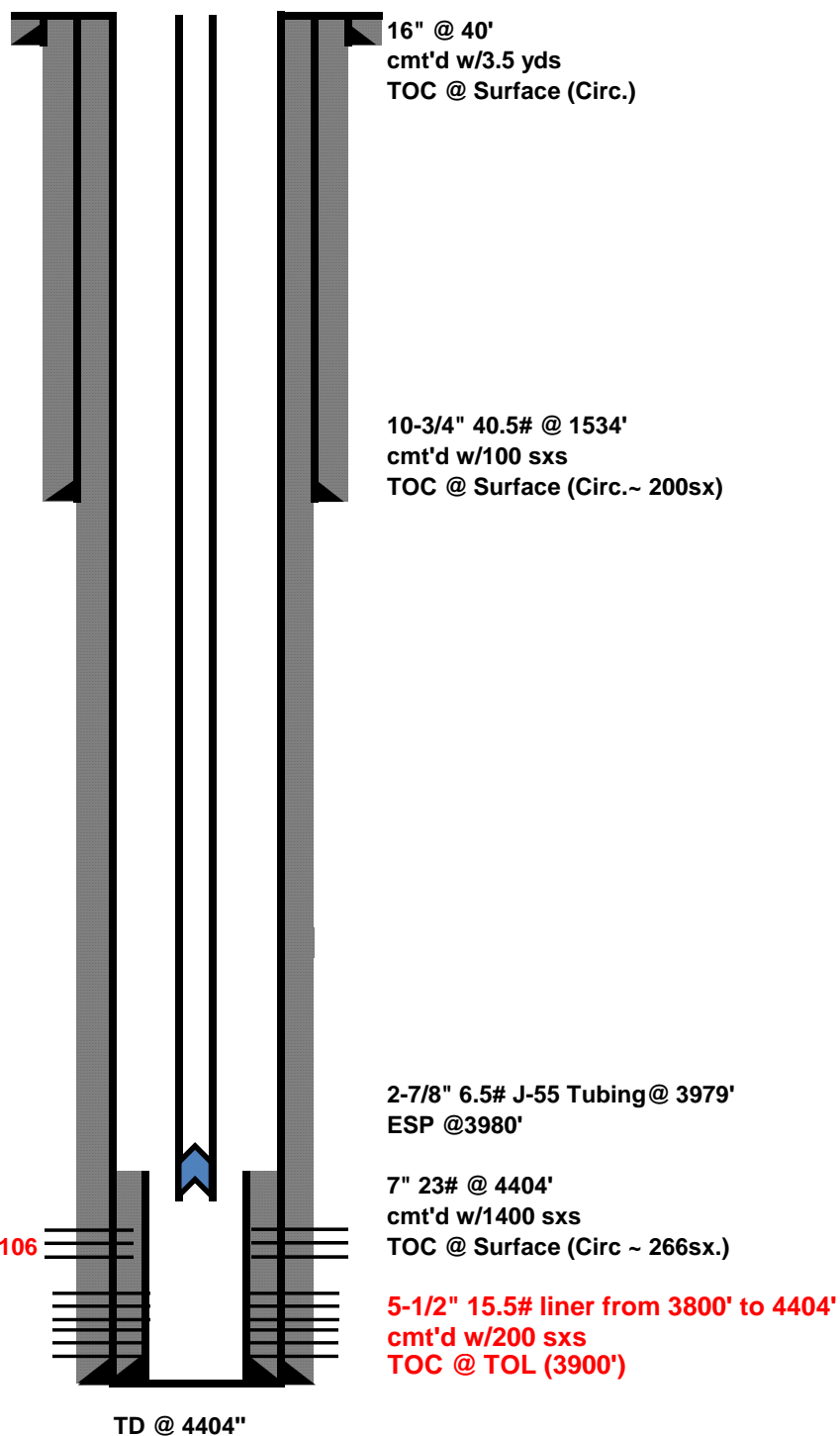
