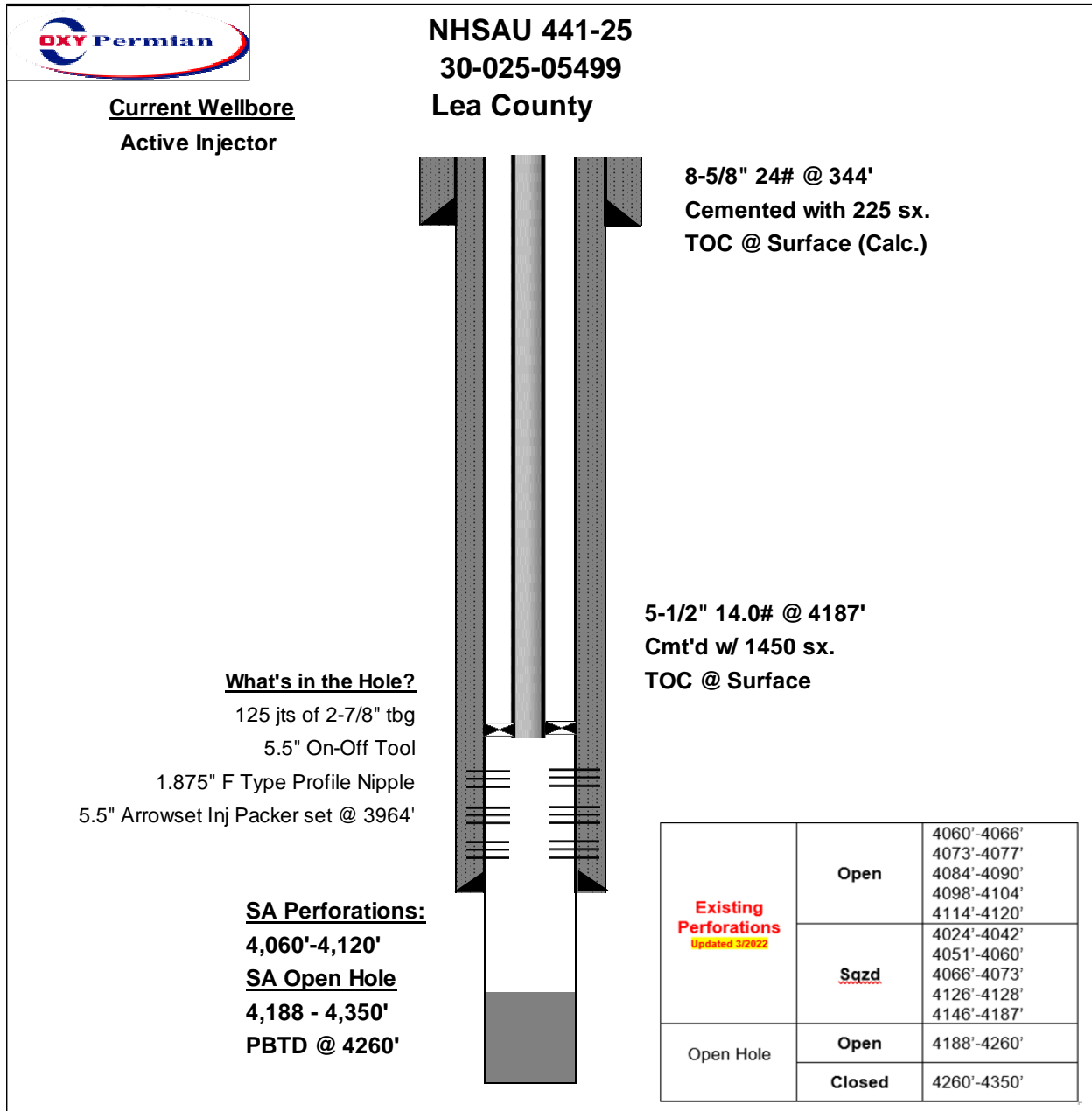

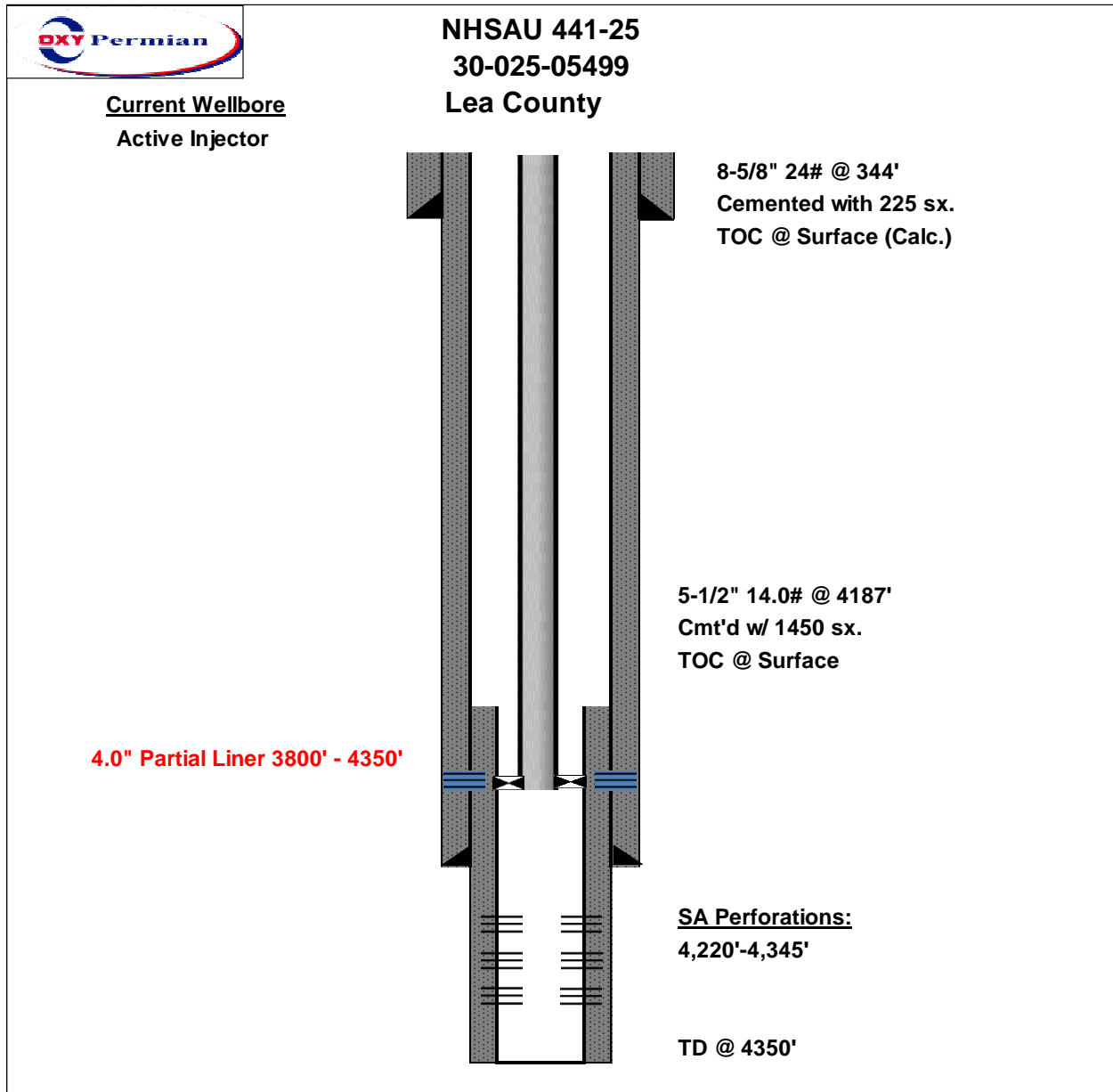
Planned procedure:

- MIRU PU
- POOH with Injection Equipment
- RIH with cement retainer & set at ~3950'
- Cement squeeze existing perforations and openhole. Sting out retainer & POOH with workstring.
- RIH with bit. DO CICR & cement to 4260'. Pressure test squeeze. Continue drilling to new TD of 4350'.
- RIH with 4" partial liner. Land liner from ~4350'-3800'. Cement liner in place.
- RIH w/ 4.75" bit & DO to top of liner. POOH with bit, RIH with 3-1/8" bit and CO to PBTD, POOH with bit.
- RU WL and run cased hole neutron porosity log
- Perf the following gross interval: 4224'-4340' (3-jspf)
- POOH and RD WL, RIH with PPI-tool & acid stimulate new perfs with ~5000 gals of 15% HCL NEFE
- POOH with PPI Tool and RIH with injection eqpt.
- RD PU
- Return well to service
