Procedure Description: 1) MIRU plugging company. Set open top steel pit for plugging. 2) POOH laying down rods and pump. ND WH and NU 3K manual BOP. Function test BOP. 3) POOH laying down 2-3/8" tbg and 2-3/8" x 5-1/2" TAC. 4) TIH 2-3/8" tbg to PBTD at 4,415'. POOH 2-3/8" tbg and notify BLM. 5) MIRU WL, RIH WL w/ 5-1/2" CIBP to 3,750'. Set CIBP and spot 25 sks Class C cmt on top of bridge plug. WOC and Tag at least 3,503'. (T/Perfs) 6) POOH w/tbg. RU WL, and RIH WL. Perf 5-1/2" csg at 3,104' and squeeze 60 sxs Class C cmt. WOC and tag at least 2,880' (8-5/8" csg shoe) 7) POOH w/tbg. RU WL, and RIH WL. Perf 5.5" csg at 745' and squeeze Class C cmt until returns on surface. (11-3/4" csg shoe, Surface plug) 8) ND BOP and cut off wellhead 5' below surface. RDMO PU, transport trucks, and pump truck. 9) Set P&A marker.

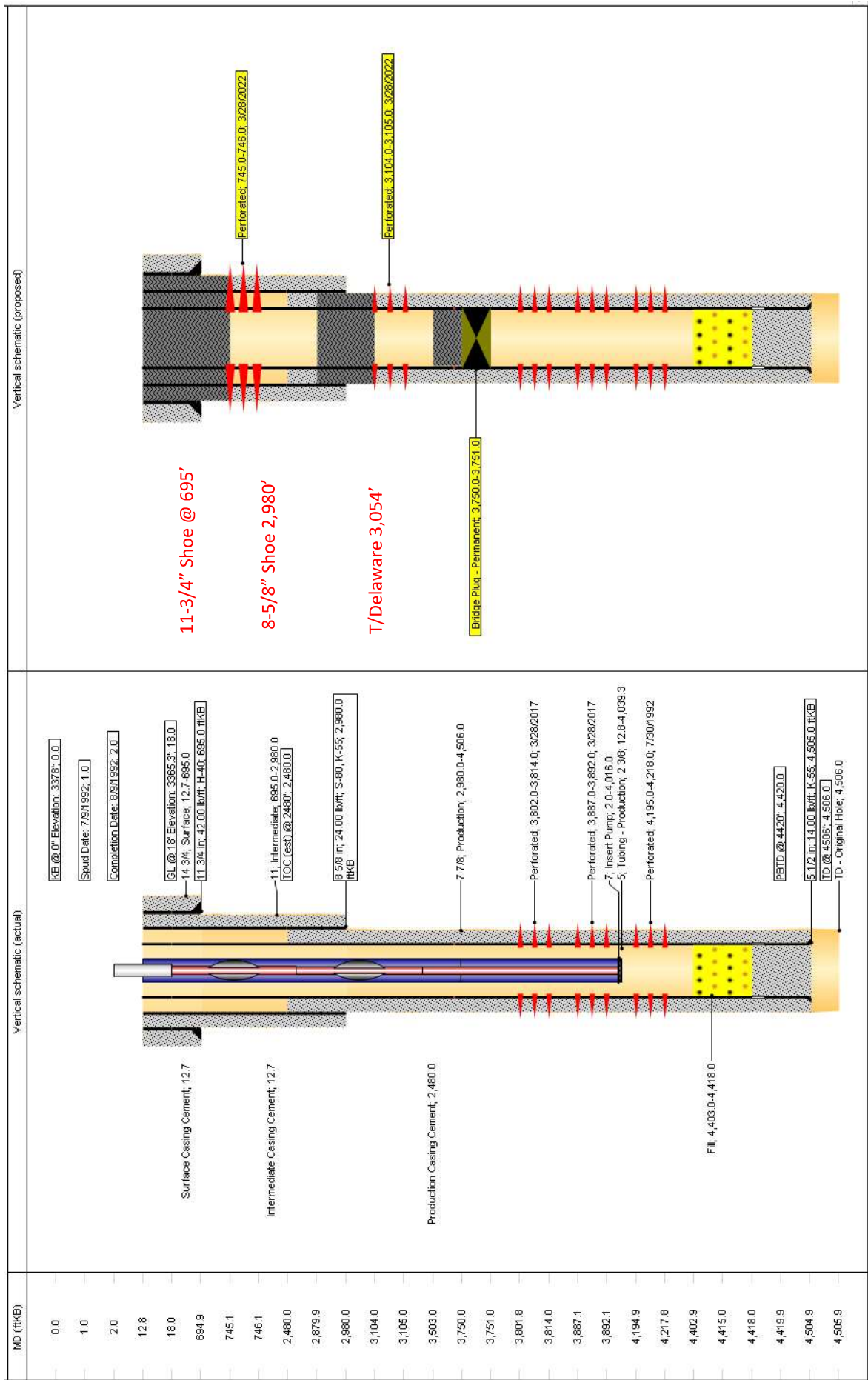
