4/4/22 – MIRU and NU BOP. Set a CIBP at 1601', tagged.

4/5/22 - Pressured up to 500 psi for 10 min, good. Texted David Alvarado with NMOCD-Artesia picture of gauge. Spotted 33 sx Class "C" cement on top of CIBP to 1404', tagged. Perforated at 1330'. Pressured up to 500 psi for 10 min, held good. Texted David Alvarado with picture of gauge. Spotted a 35 sx Class "C" cement plug from 1382'-1110', tagged. Let David Alvarado with NMOCD know where we tagged.

4/6/22 – Spotted 28 sx Class "C" cement from 164' and circulated up to surface. Topped off casing with cement.

David Alvarado with NMOCD-Artesia verified cement to surface by picture.

4/11/22 - Cut off wellhead and installed above ground dry hole marker. Cut off anchors and cleaned location. **WELL IS PLUGGED AND ABANDONED.**
