

A STRIP OF LAND ON A PARCEL OF LAND OWNED BY THE BUREAU OF LAND MANAGEMENT AND IS LOCATED IN A PART OF THE SW 1/4 OF SECTION 9, TOWNSHIP 26 SOUTH, RANGE 32 EAST OF THE NEW MEXICO PRINCIPAL MERIDIAN, COUNTY OF LEA, STATE OF NEW MEXICO:

A 30 FEET WIDE PERMANENT EASEMENT, BEING 15 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:
