Procedure Description: 1) POOH laying down rods and pump. Unseat 5-1/2" x 2-7/8" tbg anchor and POOH laying down 2-7/8" 6.5# J-55 tbg. ND WH, NU 3K manual BOP. 2) MIRU WL lubricators. RIH w/ 5.5" gauge ring & junk basket. Contact the engineer Nick Kreimeier (972-832-9601) if any tight spots exist. POOH w/ 5.5" gauge ring & junk basket (5.5" drift is 4.89"). 3) RIH WL w/ 5.5" CIBP and dump bailer to 8,650'. Set CIBP and dump 35' cement over plug. WOC and Tag at least 8,615. POOH & RDMO WL. 4) RIH 2-3/8" workstring, Load csg w/ 2% KCl with biocide and pressure test csg to 500 psi for 30 minutes. Notify BLM of result. POOH w/ 2-3/8" workstring. 5) RDMO PU, transport trucks, and pump truck.

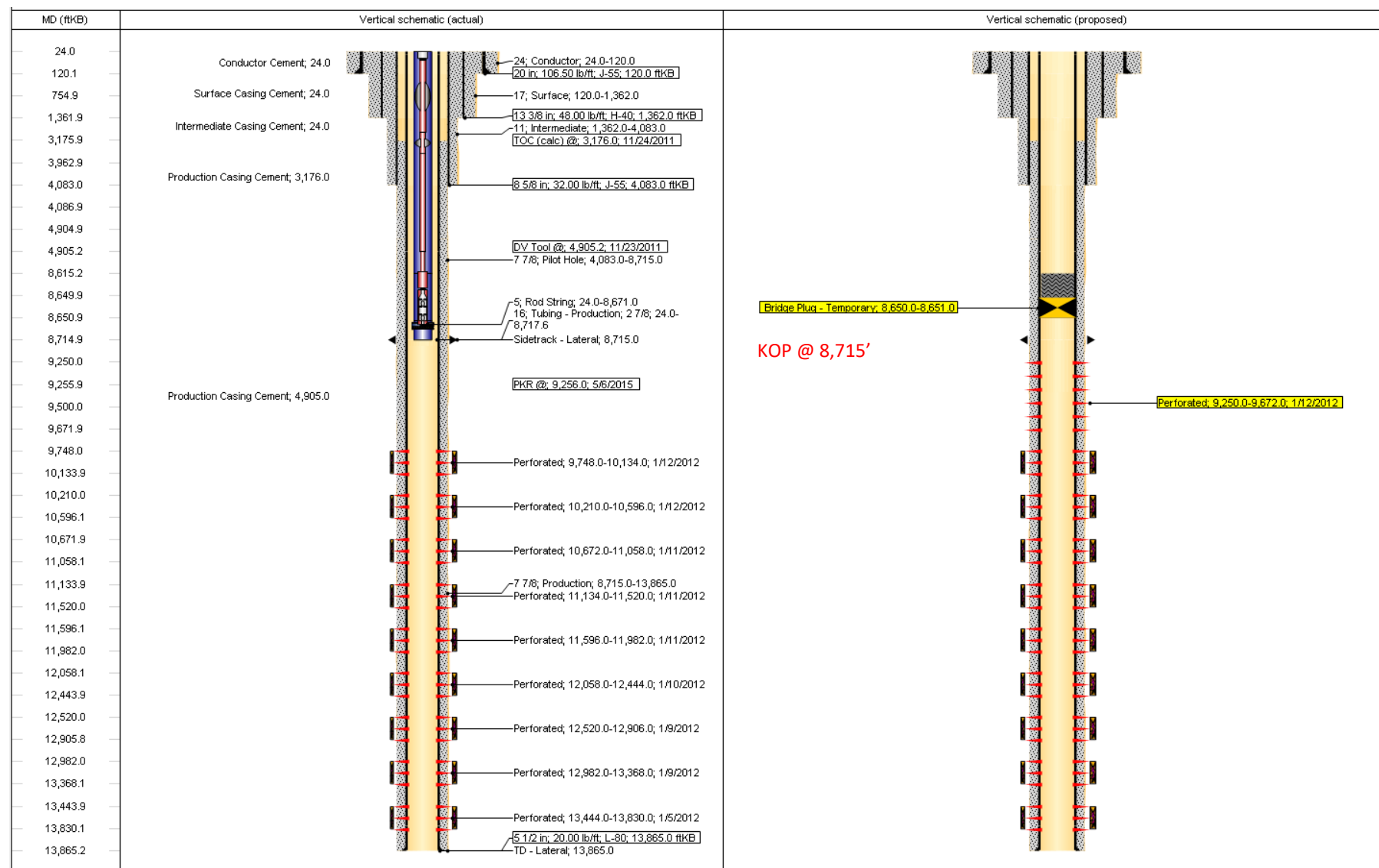
