Contact the engineer Nick Kreimeier (972-832-9601) if any tight spots exist. POOH w/ 7" gauge ring & junk basket. 3) RIH WL w/ 7" CIBP and dump bailer to 7,300'. Set CIBP and dump 35' cement over plug. WOC and Tag at least 7,265'. POOH & RDMO WL. 4) RIH 2-3/8" workstring, Load csg w/ 2% KCl with biocide and pressure test csg to 500 psi for 30 minutes. Notify BLM of result. POOH w/ 2-3/8" workstring. 5) RDMO PU, transport trucks, and pump truck.

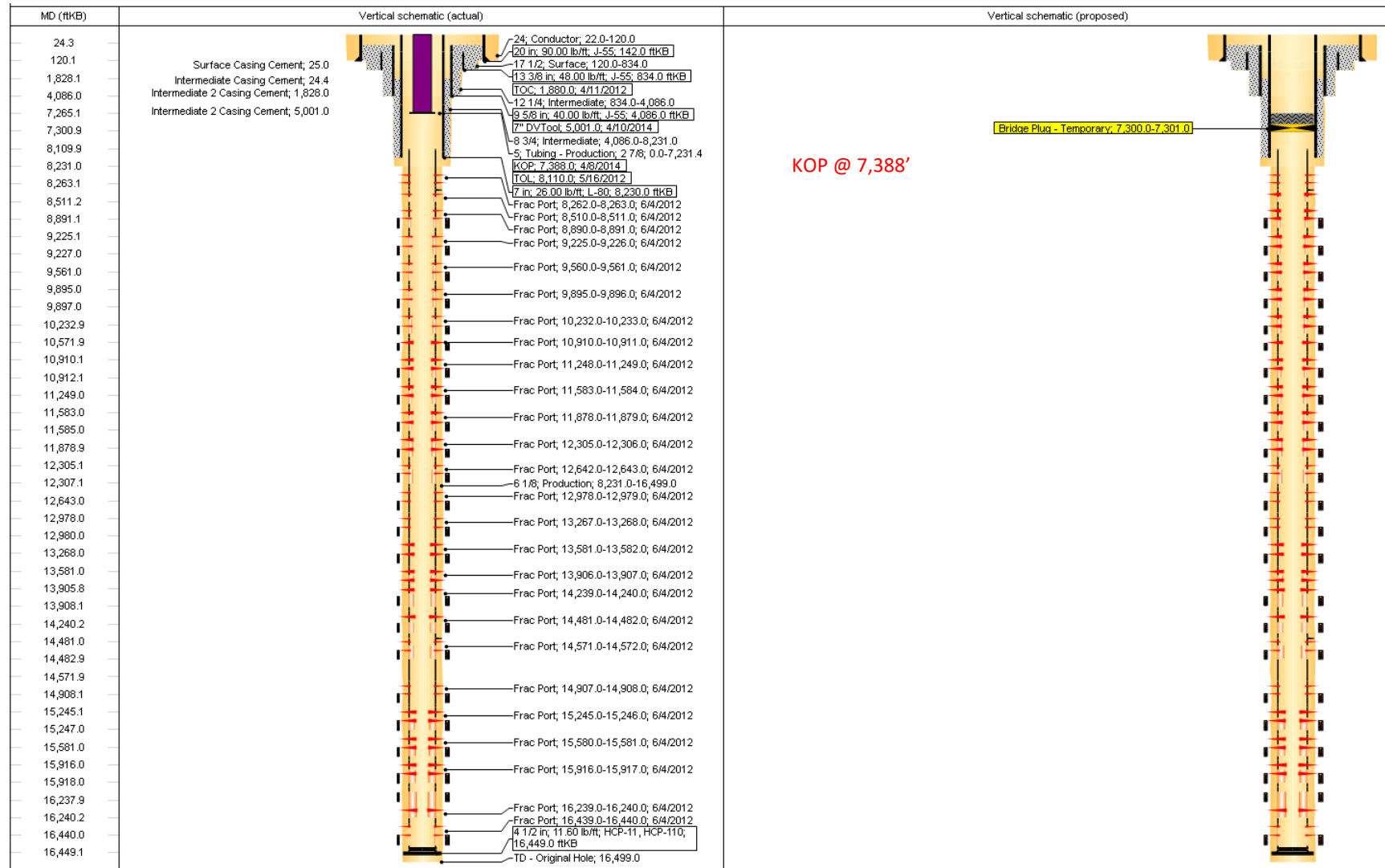
