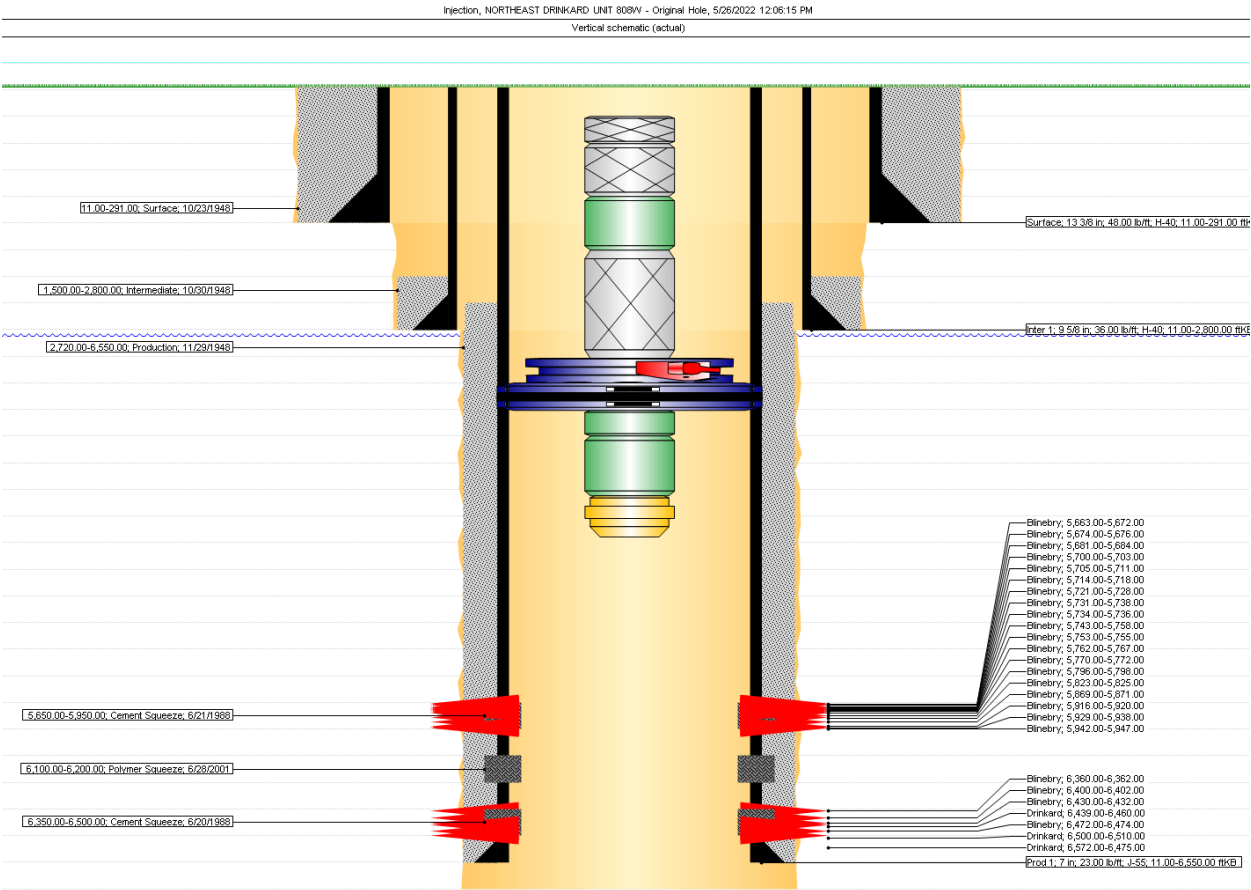

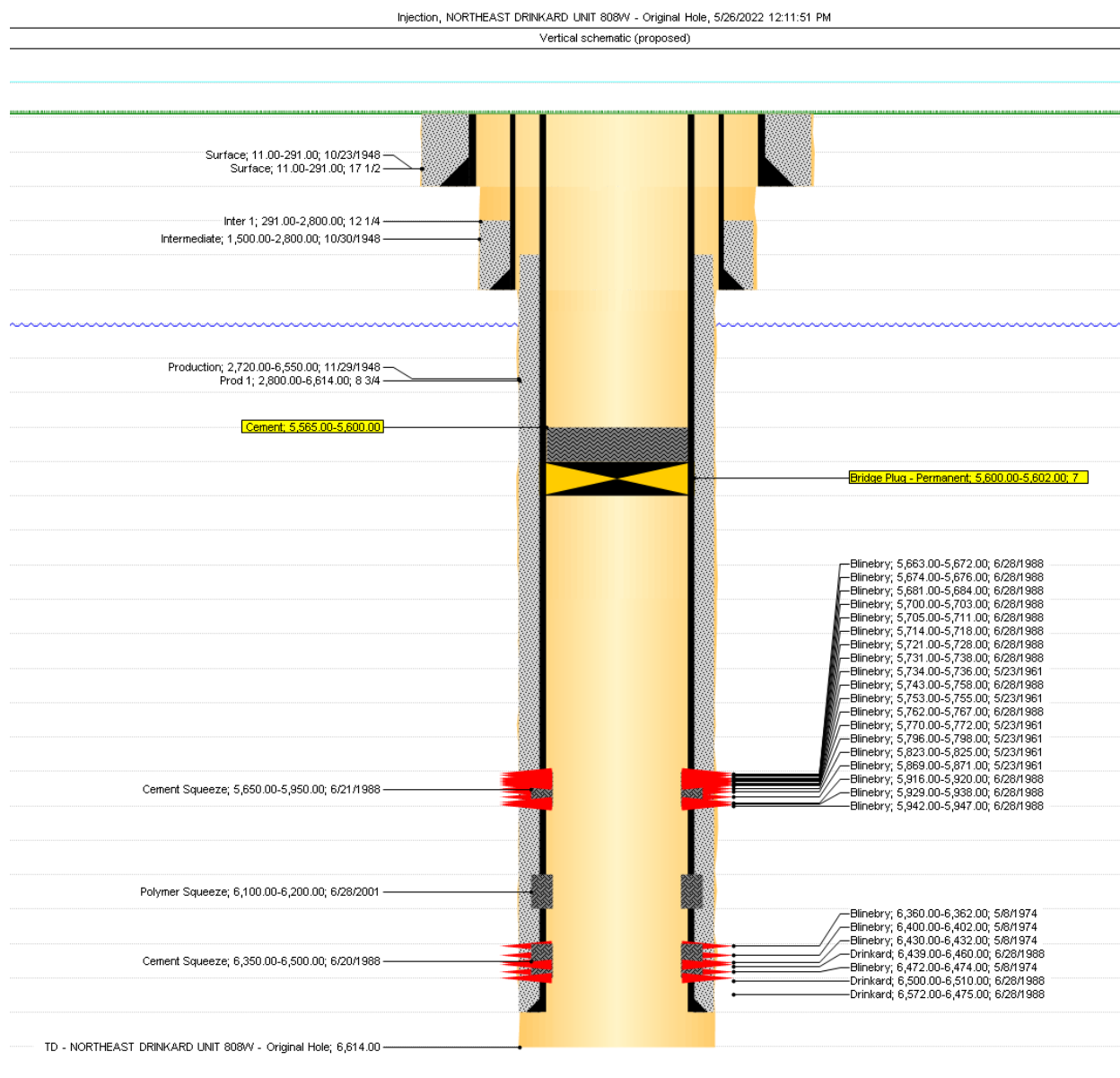

Current WBD



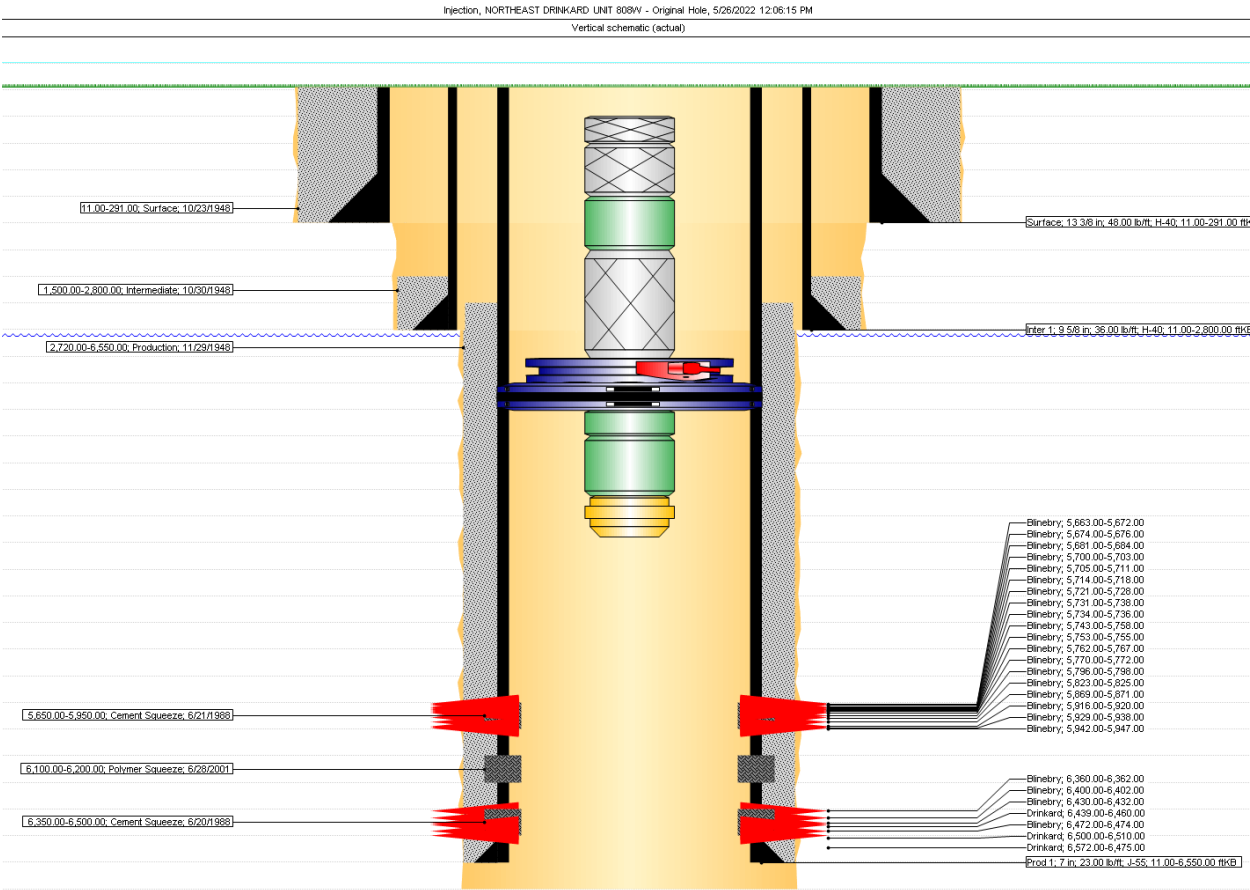
Proposed WBD

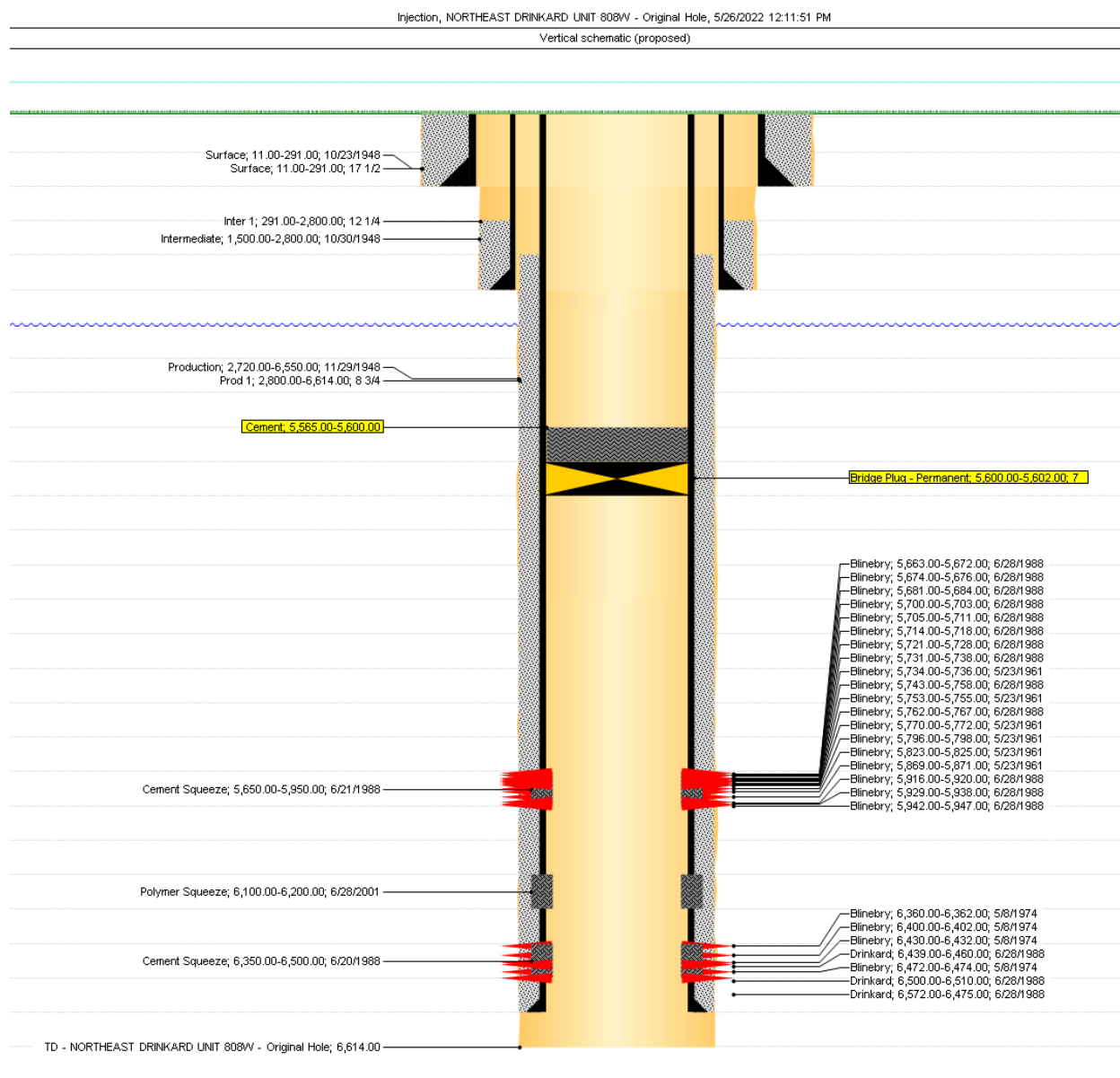
