In order to maximize recovered resources, EOG prioritized development in the Wolfcamp formation delaying the development of the Bone Spring. The simultaneous development and production of the two formations would exceed infrastructure capacities potentially resulting in the need to flare gas and/or truck oil and water.

EOGs goal is to spud this well by 5/30/23.
