Rig on location. SITP=0/SICP=0/Bradenhead=0. Long stroked pump to 500 psi. Had good pump action. Tested good. POH 54 3/4" rods. TOH 42 joints of 2-3/8" tbg, 4' sub, & tbg pump. TIH with 3-7/8" workover bit, 3-7/8 casing scraper and bit sub on 2-3/8" J55 EU8RD tbg. Tally going in the well. Ran 42 joints to a bit depth of 1364'. TOH with Scraper. Secure well. SDFN. BLM Inspector Mike Gilbreath on location to witness operations.



MU setting tool and CIBP on 2-3/8 tubing and TIH. Set CIBP at 1331'KB. Established circulation down tubing and up casing with 19 bbls. Pressure tested casing and CIBP to 640 psi. Test held. Mix and pump 12 sks, 16.44 cuft, 14.7#/gal, 2.9 bbls, 1.37 yield, type 3 cement from 1331'KB to 1143'KB. Displaced with 4 bbls of water. POH laying down 9 joints to 1038'KB. Reverse circulated clean. Mix and pump 12 sks, 16.44 cuft, 14.7#/gal, 2.9 bbls, 1.37 yield, type 3 cement from 1038'KB to 850'KB. Displaced with 3 bbls of water. Dug out cellar around WH. POH laying down 22 joints and reverse circulate clean from 326'. POH with setting tool. TIH to 326' KB. Mix and pump 22 sks, 1.37 yield, 30 cuft, 14.7#/gal, 5.4 bbls, type 3 cement from 326' to surface, circulated .5 bbls cmt out csg valve. Cut off wellhead from casing strings. Welded P&A marker on casing string. Check cement top with tubing strap. 4-1/2x7" tagged 40'. 4-1/2" tagged 30'. Crew laid down derrick. With 1" poly pipe downhole got cement to surface with 21.5 sks, 29.5 cuft, 5.25 bbls, 1.37 yield, 14.7#/gal. (circulated 1.75bbls, 7.5 sks) type 3 cement, 14.6ppg, 1.37 yield including filling cellar. Rig Down and move Rig.


P&A Subsequent Schematic Completed 5-20-22
