4/25/22 –MIRU. SIBHP – 0 PSI, SICP – 0 PSI, SITP – 0. POOH w/ Pump/Rod String. ND WH, NU BOP. Test BOP, good test. POOH/LD tbg. RIH w/ 5 ½" csg scraper to 749'. POOH. LD csg scraper. RIH and set cmt retainer @ 720'. Check injection rate under retain, went on a vacuum. Pull out of retainer. Roll csg w/ 2% KCL. Test csg, failed. **Received verbal approval from Casey Arnett, BLM & Monica Kuehling, OCD to fill csg w/ cmt from 720' to surface. Stipulation: WOC overnight and Tag TOC.**

Sting into retainer. Mix and pump: 38 sxs Class G Neat @ 15.8 PPG, 1.15 Yield. Pump 25 sxs under retainer, pressured up 1000. Sting out left 13 sxs above retainer. WOC overnight. SIW. SDFN.

4/26/22 - SIBHP – 0 PSI, SICP – 0 PSI. TIH tag TOC @ 677'. Circ csg. PT failed.

Mix and pump: 78 sxs Class G Neat, 15.8 PPG, 1.15 Yield. Circ cmt to surface. LD 20 tbg jts. Top off csg Class G cement, 1.15 Yield. WOC. Dig out WH. Tag cmt top @ 6'. Casey Arnett, BLM approved. Cut off WH. Install dry hole marker. Top off cellar with 33.5 sx Class G Neat @ 1.15 Yield, 15.8 PPG. Run 1" polyline between 8 5/8" surface csg and 5 ½" production string. Top off surface casing, fill cellar. RDMO


