Actual Procedure: Well spud on 5/12/2022 at 20:00 5/12/2022: Drill 17.5 inch surface hole to 1139 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1124 ft. Pump 20 bbls freshwater, followed by 585 sks of 13.5 ppg lead cmt, 340 sks of 14.8 ppg tail cmt. Drop plug and displace with 20 bbls freshwater, 124 bbls brine, 20 bbls freshwater. 124 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
