4/6/2022: Test BOPS. Drill 12.25 intermediate hole to 1975 ft.

4/6/2022: Run 9.625 inch 40 lb J-55 intermediate casing to 1960 ft. Pump 20 bbls chem wash, 20 bbls vis spacer, followed by 462 sks of 12.8 ppg lead cmt, 208 sks of 14.8 ppg tail cmt. Drop plug and displace with 145 bbls of fresh water. 85 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test.

4/7/2022: Drill 8.75 inch production hole to 8108 then 6.75 inch production hole to 18753 ft.

4/15/2022: Run 5.5 inch 20 lb P-110 production casing to 18736 ft MD. Pump 20 bbls chem wash, 20 bbls vis water, then 682 sks of 10.5 ppg lead cmt, 710 sks of 13.2 ppg tail. Drop plug and displace with 20 bbls sugar water and 395 bbls brine. 109 bbls cement returned to surface. Est TOC at 0 ft.
