Pump 40 bbls gel spacer, followed by 800 sks of 12.8 ppg lead cmt, 300 sks of 14.8 ppg tail cmt. Drop plug and displace with 270 bbls of fresh water. 100 bbls to surface. EST TOC at 0 ft. Pressure test casing to 1500 for 30 minutes, good test. 4/4/2022: Drill 8.75 inch production hole to 9517 ft then switch to 7.875 inch to 14650 ft. 4/11/2022: Run 5.5 inch 20 lb P-110 production casing to 14634 ft MD.
