Acidize 3478-3514' w/ 2000 gals 15% NEFE HCL acid, 400# rock salt & flush w/ 200 bbls 2% KCL water. Acidize 2858-3464' w/ 3000 gals 15% NEFE HCL acid, 800# rock salt & flush w/ 300 bbls 2% KCL water. TIH w/ production string: ~107 jts 2-3/8" J-55 tubing, SN, 4' perf sub, mud anchor. SN @ 3425'. EOT @ 3461'. RDMO. RTP.
