- Well Pad API Number
- Well Pad Plug Date
- Well Pad Operator Name

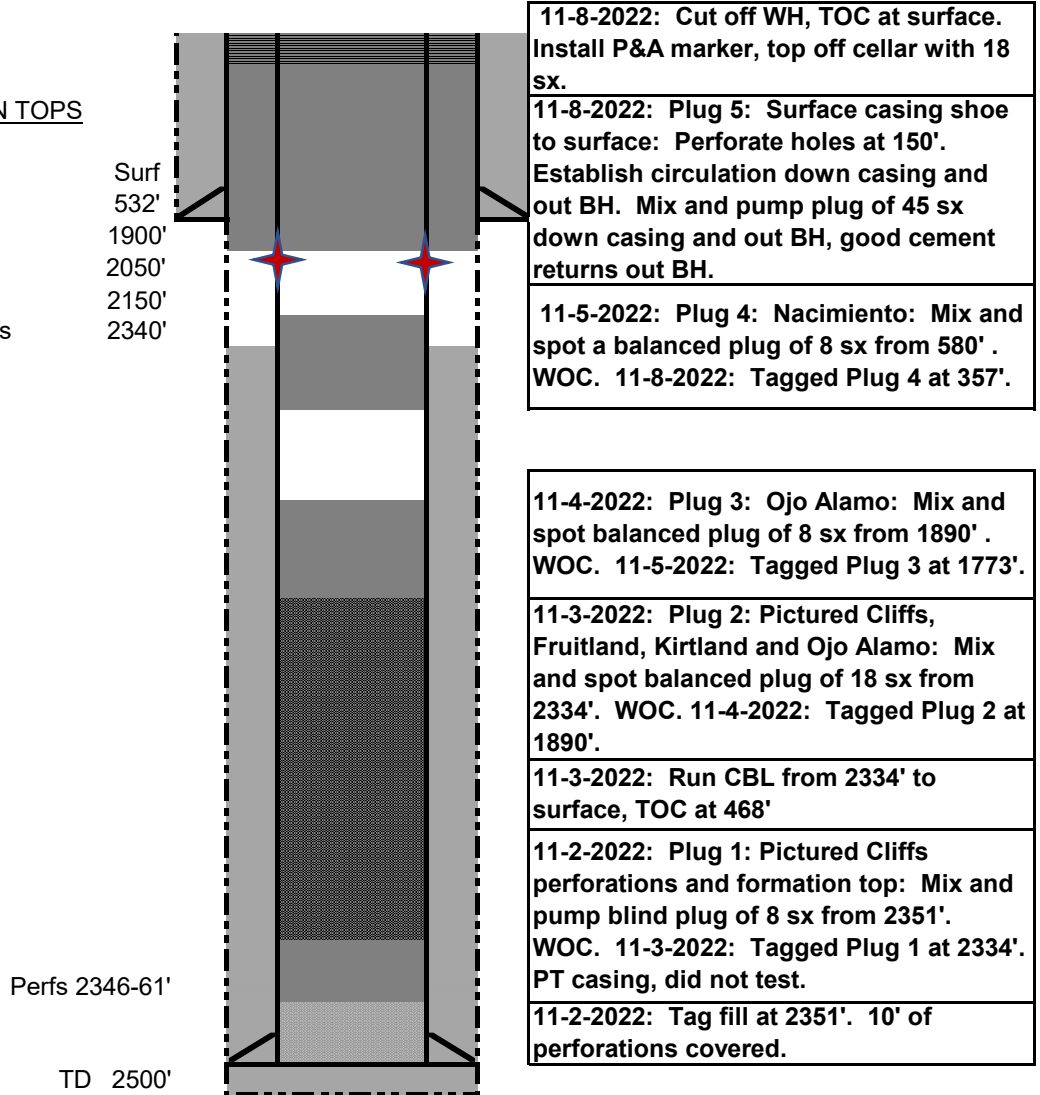

- 11-3-2022: Plug 2: Pictured Cliffs, Fruitland, Kirtland and Ojo Alamo: Mix and spot balanced plug of 18 sx from 2334'. WOC. 11-4-2022: Tagged Plug 2 at 1890'.
