6. RIH w/ sonic hammer
7. Acidize well with 7,000 gallons of 15% HCL
8. POOH laying down workstring
9. Hydrotest tbg to 80% burst
10. RIH w/ TAC, tbg and rods
11. Long stroke pump and ensure good pump action
12. RTP

Figure 1 – Current Wellbore Diagram

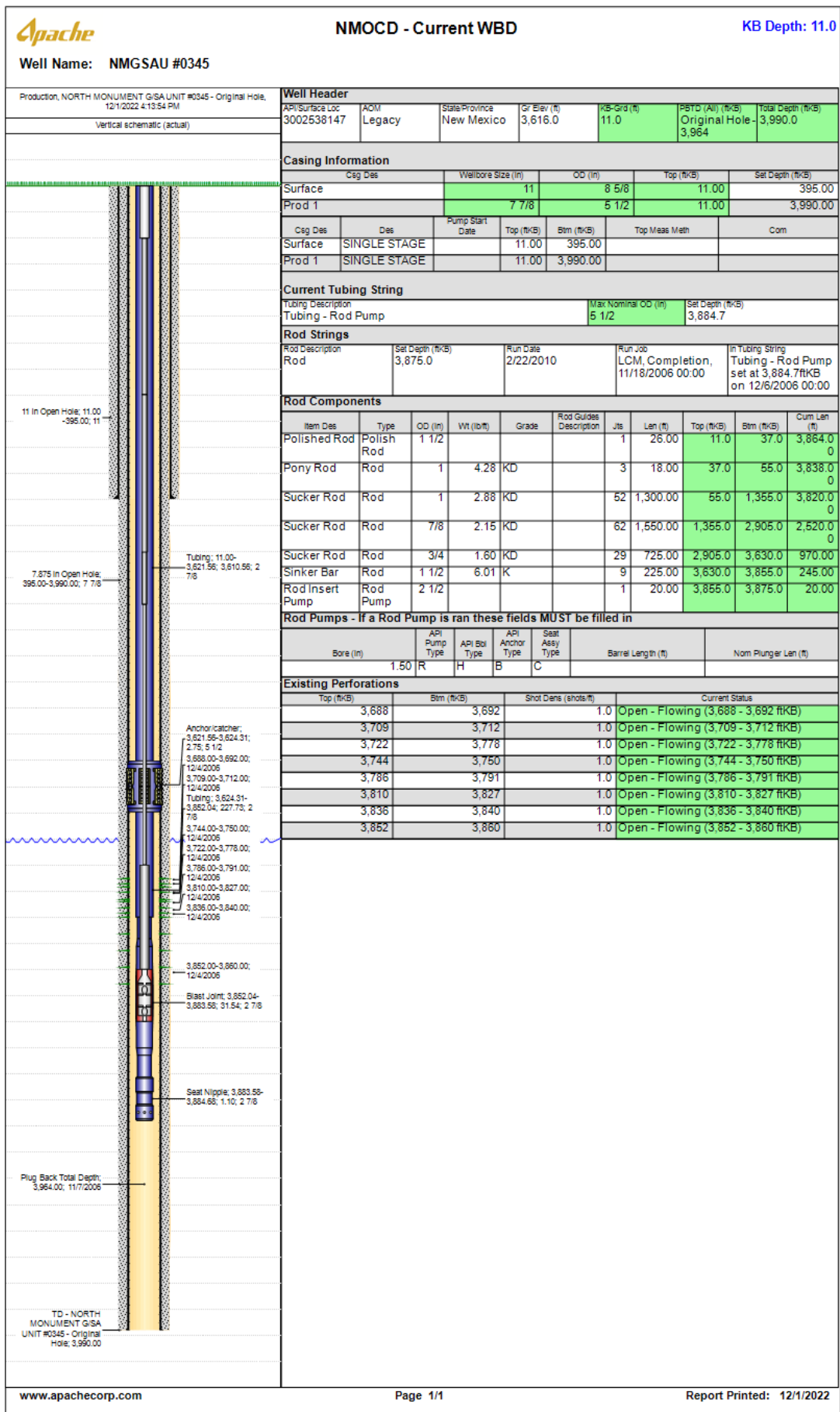
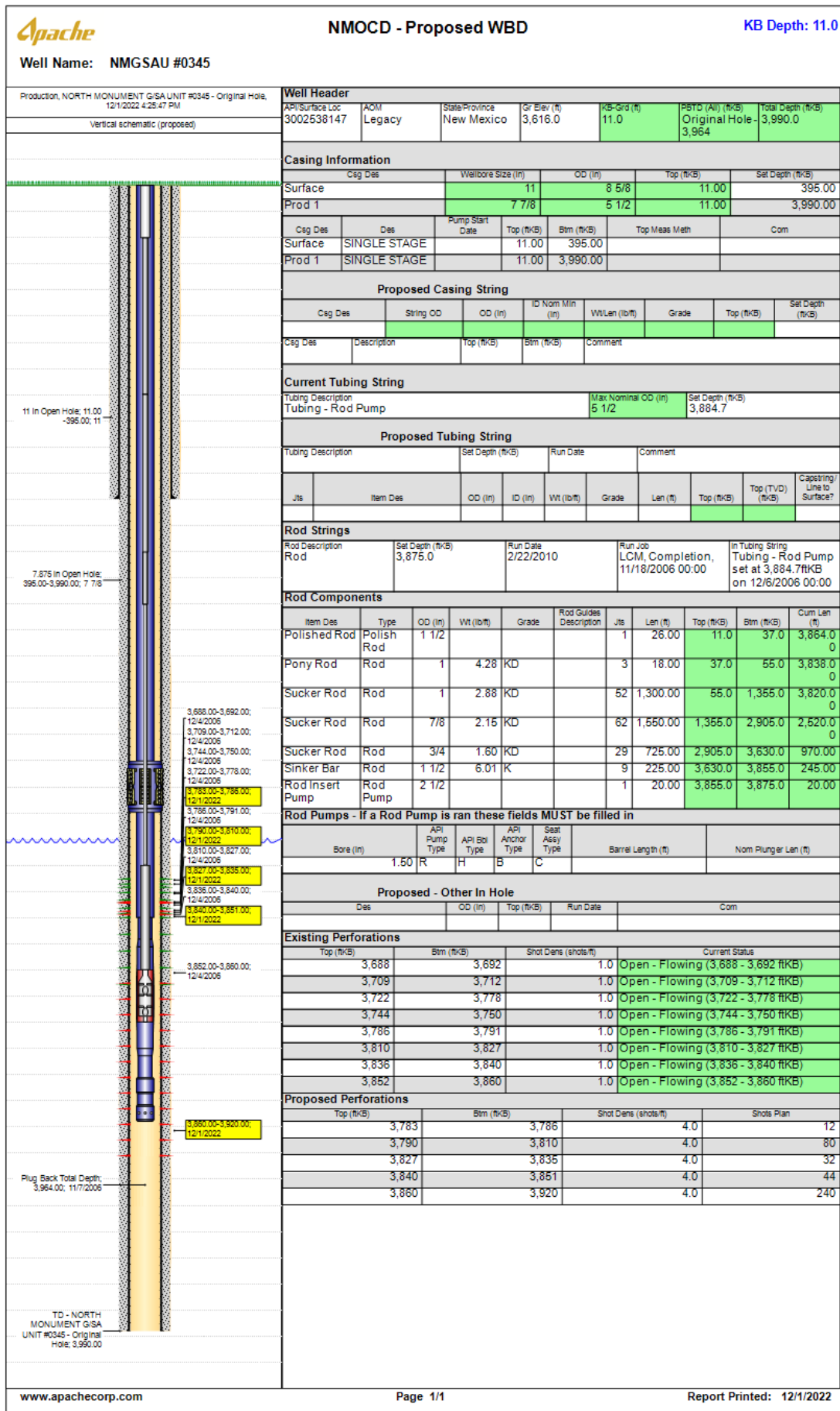


Figure 2 – Proposed Wellbore Diagram
