Good morning,

As discussed, we will need to submit a sundry for the 7-5/8" casing ran on the Arkenstone 31 Federal 171H and 172H.

The rig ran 7-5/8 29.7# HCL-80 instead of the 26.4# that was originally planned. Due to the smaller ID of the 7-5/8" 29.7# casing, we will have an annular clearance failure (<0.422") with the 5.5" Wedge 461 production casing for the 500' of planned cement overlap.

7-5/8" Wedge 425 29.7# ID: 6.875"
5-1/2" Wedge 461 coupling OD: 6.05"

So, $(6.875" - 6.05") / 2 = 0.4125"$
