Procedure Description: Revision 2. DJR respectfully requests to revise the FTP, BHL & Acreage Dedication for the subject well. The subject well is within DJRs undivided Betonnie Tsosie Wash Unit. In order to mitigate unanticipated conditions encountered during drilling operations, DJR was unable to reach the approved target depth. The well lateral was shortened adjusting the dedicated acres of the penetrated spacing unit. The revised FTP & BHL is detailed on the attached As Drilled Form C102.




